- 6. Your quotation should be submitted as per the following instructions.
 - (i) Please provide information as specified in the Schedule of Requirements (Annex A) in preparing your quotation.
 - (ii) Prices shall be quoted in **EUR** and as per the Price Schedule (Annex B). Prices in other currencies will be converted to EUR at OSCE Exchange rate for August 2008.
 - (iii) Prices shall be quoted excluding taxes.

- (iv) Prices quoted shall be **CIP Tashkent** according to the current edition of INCOTERMS published by the International Chamber of Commerce, Paris
- (v) Your quotation shall be valid for a period of **two weeks** from the deadline for receipt of quotations.
- (vi) Your quotation shall bear the RFQ Reference Number and Title.
- 7. Quotations determined to be substantially responsive to the requirements specified in this RFQ will be evaluated by comparison of their prices.
- 8. The OSCE General Conditions of Contract (to be viewed on www.osce.org/tenders/ shall apply to any contract/purchase order awarded as a result of this RFQ.

The OSCE reserves the right to accept or reject any quotation, and to annul, in whole or in part, or to suspend the process and reject all quotations at any time prior to the award, without thereby incurring any liability to the affected firm or firms or any obligation to inform the affected firm or firms of the reasons for the OSCE's action.
