- b. The Danish stock of APM is intended for demonstration, training and development purposes.

These include:

- Demonstration of the effect of an APM.
- Training of engineer units on how to clear APM.
- Training of Conventional Munitions Disposal personel.
- Training of NGO mine clearance teams.
- Testing of mine detection and disposal equipment.

New APM mines are only acquired in order to replenish stocks in order to continue training for the above mentioned purposes. APM are not used for the purpose of training in mine laying.
