DECISION No. 192

The Permanent Council,

Acting in accordance with the relevant provisions of the OSCE Financial Regulations (DOC.PC/1/96) as approved by the Permanent Council on 27 June 1996,

Recalling its Decision No. 186 and Decision No. 190, and

Taking note of the preliminary information provided by the Secretary General on the availability of funds from the Voluntary Fund to support OSCE Action for Peace, Democracy and Stability in Bosnia and Herzegovina for the purpose of partial financing of the supervision and monitoring of Republika Srpska National Assembly elections,

- Approves the budget for OSCE supervision and monitoring of the 1997 National Assembly elections in Republika Srpska in the amount of ATS 155,170,502, as set out in Annex 1, which will proceed on the basis of the Concept Paper contained in the paper entitled "Supervision and Monitoring of the 1997 National Assembly Elections in Republika Srpska. Cost Estimates" circulated by the Secretary General on 13 October 1997 (PC.IFC/9/97 Restr.);
- Decides that all available funds from the Voluntary Fund to support OSCE Action for Peace, Democracy and Stability in Bosnia and Herzegovina will be used for financing of the expenses related to supervision and monitoring of the election mentioned above and that any residual expenses for the supervision and monitoring of these elections will be financed in accordance with the regular OSCE scale of distribution;
- Tasks the Secretary General with submitting to the Permanent Council through the informal Financial Committee, not later than 6 November 1997, detailed information on the availability of funds from the Voluntary Fund to support OSCE Action for Peace, Democracy and Stability in Bosnia and Herzegovina for the purpose of partial financing of the supervision and monitoring of Republika Srpska National Assembly elections and requests the OSCE Troika to release all the available funds without delay.

<u>Interpretative statement under paragraph 79 (Chapter 6) of</u> the Final Recommendations of the Helsinki Consultations

By the delegation of Luxembourg-European Union:

"With regard to the decision adopted today by the Permanent Council concerning the financing of the OSCE supervision of the National Assembly elections in the Republika Srpska entity of Bosnia and Herzegovina, it is the understanding of the European Union that this decision, which foresees that a substantial amount of the adopted budget will be financed from voluntary contributions, does not set any precedent regarding the release of voluntary contributions. The release of voluntary contributions should, as a rule, not be subject to the OSCE budgetary decision-making process."
