## **Annotated Agenda**

Chapter VIII of the United Nations Charter encourages regional arrangements like the Organization for Security and Co-operation in Europe to support the UN Security Council by helping to maintain international peace and security, particularly with regard to the peaceful settlement of disputes. An August 2013 Presidential Statement issued by the Security Council underscored the importance of further developing and strengthening cooperation between regional organizations and the United Nations, highlighting the important role that regional and sub-regional organizations can play in conflict prevention, peaceful settlement of disputes, peacekeeping and post-conflict peacebuilding.

The 2014 OSCE Security Days conference on *The OSCE and Chapter VIII of the United Nations Charter: Confronting Emerging Security Challenges in the Euro-Atlantic and Eurasian Space* is intended to inspire a highly interactive dialogue on the Organization's responsibilities – and opportunities – as a regional arrangement under Chapter VIII of the United Nations Charter in the contemporary security context. By engaging practitioners and seeking recommendations for both the policy and operational level, the event will explore innovative ways for the OSCE to strengthen its co-operation arrangements with the United Nations and other regional organizations, particularly in the areas of conflict prevention (early warning and early action) and conflict resolution (mediation). Each session will feature a dynamic, moderated panel discussion among high-level participants, with an opportunity for questions and answers from the audience, who will include representatives of the 57 OSCE participating States, 11 Partner States, invited guests from international and regional organizations, research and academic institutions, media and young people, including the Carnegie Next Generation Fellows Program.

The event will make full use of social media and Internet technologies to engage with young people throughout the OSCE area and around the world in real time.

# Session 1: Setting the Scene: Challenges and Opportunities for the OSCE in the Contemporary Security Context

The OSCE Secretary General will introduce this session, which will assess the growing complexity of the challenges and threats to security in the OSCE region. In addressing this issue, the panel may touch upon some of the most urgent challenges in the OSCE region and adjacent areas that might have a direct or indirect impact on our collective security, such as the current crisis in Ukraine, the implications of the ISAF withdrawal from Afghanistan on regional security, or the impact of the on-going crisis in Syria. These threats are becoming increasingly multi-dimensional and transnational, affecting both regional and global security. Today's rapidly evolving security context, coupled with widespread economic hardship, requires international and regional organizations to find ways to work together more effectively, prevent duplication of efforts and competition for resources, and to reinforce the full coherence and synergy of collective international action. Emerging threats to peace and security in the OSCE area, including the re-emergence of Cold War thinking and rhetoric, are presenting new challenges but also opportunities for enhanced interaction between the OSCE, the UN and other regional organizations. How can closer coordination and cooperation be encouraged? In which areas is cooperation most effective? How can an efficient division of labour that makes full use of each organization's comparative advantages be established?

# Session 2: Regional Organizations in Mediation and Conflict Resolution: Finding Lasting Solutions

United Nations General Assembly resolution 65/283 underscores the role of mediation in the peaceful settlement of disputes and emphasizes the importance of partnerships and co-operation between international, regional and sub-regional organizations and the United

Nations, as well as among these organizations themselves, to ensure the coherence and complementarity of mediation efforts. Giving special focus to the OSCE region, this session will discuss tools for sustainable peaceful conflict resolution, bearing in mind the particular and important contribution of women. It will cover mediation, conciliation and arbitration, confidence building and further steps to sustain the reconciliation process. The potential contribution of civil society and Track II institutions such as think tanks and academic institutions will also be part of the discussion, as well as the need for capacity building in mediation and conflict solving. Some questions that might be considered include: When is the right moment to engage? What are the most effective tools to encourage all parties to participate and to sustain their commitment to the process? What are the comparative advantages of the OSCE and other regional and international organizations? How can they work together to improve coordination particularly in the early phases of conflict resolution and to fill gaps in capabilities throughout the process?

# Session 3: The Role of the OSCE as a Regional Organization in Conflict Prevention: Early Warning/Early Action

Chapter VIII of the UN Charter, reinforced by Article 33 of Chapter VI, calls on Member States that have entered into regional arrangements to "make every effort to achieve pacific settlement of local disputes through such regional arrangements." Can this approach be renewed and expanded in light of current challenges? How can the culture of "reaction" (peacekeeping, peacemaking and post-conflict rehabilitation) be shifted towards a culture of "prevention" (early warning and early action)? How can we better address conflict triggers as well as deeply rooted causes of conflict? How can conflict prevention methods be promoted more effectively and their profile raised? In the OSCE area in particular, how can regional organizations build stronger partnerships and closer and more operational co-operation with each other and with the United Nations in order to prevent emerging crises from spreading regionally and globally? Are ad hoc regional responses sufficient, or would more structured partnerships be more effective? How can current regional frameworks be used to better incorporate regional, national and local actors (both governmental and nongovernmental) in efforts to prevent conflict?

How would this fit into the OSCE Helsinki+40 process and the need to reaffirm the importance of the Helsinki Principles and their implementation to avoid a return to Cold War logic? What are the new global challenges and how should the OSCE prepare to address them? How can the dynamic dialogue initiated at the Security Days conference be continued and deepened?
