10.00 – 11.30	<p>SESSION I: Current tendencies in news media distribution: the state of affairs in Central Asia and other OSCE participating States</p> <p><i>The global trend of mobile devices being users' primary access point to news and entertainment makes mainstream media adjust their formats and means distribution to mobile environment. According to Cisco Visual Networking Index 74% of all Internet traffic in 2018 will become video. The media in Central Asia are taking steps in harnessing new distribution platforms and delivering news to wider audiences. The subregion as a whole has done comparatively well in mobile telecommunications, due to improved coverage and affordable devices. Mobile Internet penetration rates in the countries of Central Asia exceed 100%, mostly above the global average of 96%¹. As telcos upgrade their networks to 3G and 4G, existing users find themselves with the means for faster Internet access, and the capacity to pursue multiple activities. 12.00 – 13.30	<p>SESSION II: Gatekeepers in the new media environment: new professional challenges and opportunities for journalists and media outlets in the OSCE area</p> <p><i>Increasingly, mobile gadgets become the users' gateway to the outside world, including TV, radio and news media. Media content is increasingly distributed via mobile applications and messenger services. The very same users however often rely on social media as a source of news and a platform for discussion. For years academics have written about the so-called 'echo chambers' of the likeminded in social media groups, while user-generated content has often led to an instant global distribution of false information. Yet this year Facebook has announced it would start distributing newsfeeds of established media organisations, including premium content. Among these, the Russian platforms VKontakte and Odnoklassniki as well as the video-hosting platform rutube.ru maintain the dominant position. Computer algorithms increasingly decide which piece of news users are going to see. The new recommendations, which build upon the previous HCNM Guidelines on the use of Minority Languages in the Broadcast Media (issued in 2003), will focus on freedom of expression in the digital age. Dr. Dmitry Nurumov, HCNM Expert on Media and National Minorities, will engage in a discussion with the audience on the relevance of this document to the Central Asian context, exploring good practices and challenges related to the role of media for national minorities and integration of multi-ethnic societies in the region.</i></p>

<p>16.30 – 18.00</p>	<p>WORKSHOP II: Legal framework and the role of self-regulatory institutions in countering violent extremism (CVE) and hate speech: best practices exchange in the OSCE area</p> <p><i>The discussion will highlight the role of media organisations and professional associations in reporting on terrorism and extremism issues. The participants will be invited to discuss the role of legal provisions and that of the counter-narrative in containing the threat of the extremist discourse in the (social) media. The discussion on open journalism will also aim to emphasise the changing role of journalists in the online environment and the participation of audience in gathering and disseminating information, which add new challenges for ethical journalism.
