

Discrimination in Québec

The Raelian Movement was always involved in many humanitarian actions since its beginning. Show a few examples: peace protests, Gay Prides, 'No To Suicide' conference, etc.
But these actions often shocked the politically correct establishment. Examples: <i>The True Face Of God</i> , <i>Yes to condoms in school</i> , <i>Yes to sharing</i> , <i>Yes to masturbation...</i>
Then, medias and politically correct defenders began to react...
In the 90, we were collecting dry foodstuff to help families in need. Following a journalistic pressure, 'Jeunesse au Soleil' dissociated from the Raelian Movement. The giver's hand became more important than the giving gesture. Discrimination was beginning.
In 1993, the Corporation of Professional Psychologists of Quebec (CPPQ ¹) did not appreciate Daniel Chabot's participation to a conference on the benefits of masturbation given by Rael and Betty Dodson. Since they couldn't attack on any aspect of the conference itself, they found some blames against him: publicity and a book on Rael's teachings. Freedom of speech never was recognized in this cause... it was bluntly rejected and Chabot was condemned to pay a disproportional fine of 5,000\$ plus charges (6,000\$). Even the Person's Rights Commission (CDPDJ ²) did not recognize the abuse perpetrated by the CPPQ, as the abuse perpetrated by CPPQ's leaders who publicly declared Chabot as guilty before the trial even happened.
Then, vicious attacks began. In 2003, two journalists from 'Journal de Montreal' infiltrated Raelian Movement and published a batch of articles. The Movement is never attacked on its core issues, but its members are exposed on the public place. This is the classical way to weaken an association: attacking its members. Therefore they violate people's private lives ...
Some individuals suffered damages following the publishing of these articles. Examples: after publication from these infiltrated journalists, many contracts were lost for Michel and Daniel Chabot. 8 complaints were filed at CDPDJ. 3 reached an agreement in mediation 5 were rejected even if, for two at least, solid proofs were presented (audio recording, emails, memos).
Protest at 'Le Salon du Livre de Montréal' (book fair) in front of 'Stanké's booth' where Brigitte MacCann promoted her book 'Rael, journal of an infiltrator'. This one filed a criminal complaint against Pierre Boly, Daniel Chabot and Véronique Rhodet. Journal de Montreal used the pretext to publish another batch of articles where we are considered as guilty when a simple complaint was filed. Two years later this complaint was rejected by the Crown Prosecutor. Not a word in the medias.
2006, a complaint was filed at CDPDJ against MacCann and Poirier from Journal de Montréal. The complaint was rejected.
2004 – During the TV show <i>Tout le Monde en Parle</i> , our Beloved Prophet is physically attacked by Serge Chapleau. On the same show, Pauline Marois demonstrated her approval by her reaction. She even tagged on in the medias the next day, especially by calling our Prophet 'raving mad'.
Police complaint against Chapleau for minor physical attack. The complaint was rejected.
After publication for the book <i>'Fiers d'être Raéliens' (proud to be Raelian)</i> , 'Salon du Livre' in Quebec City

<p>refuses to allow us a booth. Complaint filed at CDPDJ. The complaint was rejected.</p>
<p>Complaint filed against Marois... rejected</p>
<p>Marois runs for the election of a new leader for PQ. We protest against her candidacy: elementary democratic right.</p>
<p>Protest in Gatineau, November 2005: access refused to the room for Raelians wearing their medallion. Complaint filed at CDPDJ. The complaint was rejected because, we were told, they finally let us in.</p>
<p>Following Pauline Marois's statement, the Psychiatrist Pierre Mailloux called us 'abused psychiatric sick persons'... Complaint filed against Mailloux at the 'College des Médecins' (College of Physicians). The complaint was rejected.</p>
<p>The College des Médecins retains another complaint against Mailloux about black people. We ask the College des Médecins to reconsider our complaint because it looks like a double standard. Our request is rejected.</p>
<p>Complaint filed against the College des Médecins at CDPDJ. The complaint was rejected.</p>
<p>December 2006, 5 Raelians were holding a booth in Université du Québec à Trois-Rivières (UQTR) for a fundraising to help excised women in Africa: these 5 persons were shown the door out of University. Complaint filed at CDPDJ. The complaint was referred to the CDPDJ's legal service for investigation.</p>
<p>Trois-Rivières : Raelian protest and discriminatory press release from UQTR's direction. Complaint filed at CDPDJ. Both complaints were referred to the CDPDJ's legal service for investigation. Could be rejected (to be continued)</p>
<p>After publication of this press release, Jean-Luc Mongrain, host on TQS TV station, said: "...you take the ass out, the ass on a shovel..." "...don't lose time, just say "out you go", that's not complicated..." Complaint filed at CDPDJ. The complaint was rejected under the excuse of freedom of speech.</p>
<p>Great Lawsuit presented by the Lawyer, Mr Fournier Judges refused to hear the request.</p>
<p>Rael sued the newspaper 'Le Droit', in Ottawa, for publishing defamatory statements. A more than vicious verdict dismissed Rael.</p>
<p>Complaint from about fifteen Raelians in front of Small Claims Court against Journal de Montreal for publishing their picture without consent: current cause that should find an end on September 11, 2007</p>
<p>Autumn 2006, professor Forget (Université du Québec à Montréal (UQAM) made a defamatory statement against Daniel Chabot, saying he was condemned by CPPQ for promoting pedophilia (recording presented a proof). Complaint filed at the Ombudsman of UQAM. They refused to consider the complaint.</p>
