H.E. Igor Davidović, Ambassador of Bosnia and Herzegovina to the OSCE on the Joint statement by High Representative Catherine Ashton and Commissioner Štefan Füle on the Serbian Declaration on Srebrenica, as issued on 31 March 2010, to the Permanent Council, 15 April 2010

Dear Mr. Chairman,

The tragedy in Srebrenica remains a painful reminder not only for citizens of Bosnia and Herzegovina but for the entire world community. It is and should be a reminder for all of us as well as a warning sign for our collective conscience.

The stabilization of Bosnia and Herzegovina and the region of the Western Balkans depends on the normalization of the societal relations between the neighboring countries. This can only be achieved through process of reconciliation at all levels of society. It is important to understand the differences between the individualization of criminal responsibility towards crimes committed on one side and the condemning of all crimes which have taken place during the conflicts on the other, on the territory of the former Yugoslavia are key points on the path to build up confidence, reconciliation and co-operation in the Region.

Nevertheless, it is up to every country and its leadership to decide on how and in which way to condemn the atrocities. It is inconceivable that this can happen without due process of justice, reaffirming standards of the International Law and International Court of Justice Judgment. Therefore the full and unrestricted co-operation with the ICTY remains an essential requirement for continuing progress towards the EU.

The international community needs to ensure it has the appropriate mechanisms in place to prevent and address such crimes in future. The OSCE can also draw lessons for its own efforts, to the extent that the early warning mechanisms must be relevant and timely with the post-conflict operations - (such as facilitating the return of all refugees, implementing property law, fostering human rights, monitoring war crimes trials and promoting interethnic dialogue.) more to address both immediate effects as well as root causes.
