WHO WE ARE

The OSCE Evaluation Network unites project/programme and evaluation managers, monitoring and evaluation focal points and other like-minded OSCE officials from the Secretariat, field operations, and institutions.

MANDATE

The Internal Oversight Mandate of the OIO, as well as the OSCE Evaluation Framework Administrative Instruction (No. 1/2013), which outlines the key principles and standards for evaluation in the OSCE and provides guidance on the different types of evaluations used in the organization.



Established and moderated by the OSCE's Office of Internal Oversight from 2013 up to date;

To strengthen the evaluation culture in the OSCE and to improve results-based management overall;

To enhance learning by sharing best practices and lessons learned on Monitoring & Evaluation;

To create a community of practice engaged in supporting evaluation for evidence-based planning and decision-making;

To build capacities of evaluation professionals and management across the OSCE.



HOW WE WORK

THE EVALUATION NETWORK CONDUCTS, INTER ALIA, THE FOLLOWING ACTIVITIES:

- **Webinars** 4-6 times per year on topics that are relevant for the Evaluation Network community and the organization at large;
- In-person **Evaluation Network meetings** held annually to share M&E practices, lessons, and achievements;
- Online **SharePoint** platform for peer-to-peer exchange and learning;
- **Free Virtual E-Library** with a collection of evaluation guidelines and tools, good practices, templates and other relevant guidance material.
- **Distribution of OSCEval News**, OIO's evaluation newsletter, **evaluation reports**, and other communication products.

CROSS-DIMENSIONAL CO-OPERATION

In an effort to monitor and strengthen the evolution of the OSCE's evaluation culture, the *Office of Internal Oversight* co-operates with the *Programming and Evaluation Support Unit (PESU) / Conflict Prevention Center (CPC)* at the OSCE Secretariat, and jointly builds capacity for evaluation and evaluation management in executive structures across the OSCE.
