#### ***Panel 1 – What is ‘Demand’ and why must it be discouraged***

*The obligation for States to discourage the demand that fosters all forms of exploitation resides in various international instruments, including most significantly Article 9(5) of the Palermo Protocol.*

*Before States can effectively implement measures to discourage demand, there must first be an understanding of what constitutes demand and its role in fostering trafficking in human beings. This requires unpacking the financial relationships that motivate trafficking in human beings, as well as recognizing that demand manifests differently depending on the form of exploitation, with each form of exploitation possessing unique market characteristics that alter the role played by end users of goods and services produced by or extracted from trafficking victims. To shed light on these relationships and characteristics, this panel will explore the nature and scale of demand within the context of trafficking for forced labour and sexual exploitation, outline international obligations, and articulate the importance of demand as a means of prevention.*

### **14:05 – 15:35      Panel 2 – Tackling the demand that fosters trafficking for forced labour**

*Discouraging the demand that fosters trafficking for forced labour requires States to enact and enforce laws and regulations, including in public procurement, that reduce and prevent the purchase of goods and services produced by or extracted from trafficked labour. Understanding the tools and policy options at their disposal, as well as their strategic benefits in preventing demand, will help States do*

*this effectively. Panel 2 will therefore discuss promising initiatives, outline existing resources on strengthening protection measures, highlight the role of cross-border collaboration and the harmonization of procurement principles, describe the path to adopting national due diligence legislation, and discuss the benefits of collaboration with civil society actors.*

**16:00 – 17:30 Panel 3 – Tackling the demand that fosters trafficking for sexual exploitation**

*Trafficking for the purpose of sexual exploitation is the most common form of THB within the OSCE region, and generates nearly two-thirds of all profits from trafficking globally. The scale of this crime, as well as its unique gender and market characteristics, elevate the need for States to prioritize combating the demand that fosters sex trafficking within their prevention strategies. To help States improve their national responses, this panel will introduce some existing promising practices on how to prevent, deter, disrupt, and penalize the demand that fosters THB for sexual exploitation, including methods of targeting online forums that facilitate the exploitation of trafficking victims; codes of conduct that prohibit activities which foster sexual exploitation; education programmes for buyers and young adults; and effective legislative measures that target the impunity currently enjoyed by users of sexual services from victims.*
