This map of eastern Ukraine is meant for illustrative purposes and indicates locations mentioned in the report, as well as those where the SMM has offices (monitoring teams, patrol hubs, and forward patrol bases) in Donetsk and Luhansk regions. (In red: forward patrol base from which SMM staff has temporarily relocated since 27 September 2016 based on recommendations of security experts from participating States.)
