# PANEL I: Reporting on terrorism in online, print and electronic media

Journalists play an important role in covering violent extremism and radicalization that leads to terrorism. But they need exercise careful judgement. It is important that reporting on this issue is balanced and that journalists carry out their work of informing the public, while also avoiding the risk of actually helping terrorists achieve their aim of dividing societies and spreading fear. This session aims to address the main problems with covering terrorism, which has become more complicated with the acceleration of the news cycle and widespread use of social media. The speakers will discuss professional standards of reporting, the media space allocated to this topic and the application of human rights standards in reporting about violent extremism and terrorism.

# PANEL V: Analysis of social media in process of radicalization

The use of social media by terrorist groups has become one of the most pressing global issues. Terrorist organizations are using social media platforms for communicating their ideologies and recruiting and training their followers, as this type of communication is both cost and time effective. Attempts to regulate this phenomenon can often pose a threat to freedom of expression. On the other hand, the role of social media in combatting terrorism is evolving. Speakers will discuss counter-messaging as a way to fight off terrorist propaganda and policies across the European Union that aim to address this issue, while also respecting human rights standards.

### Terri Judd

**Terri Judd** is a Countering Violent Extremism and Strategic Communications consultant, specialising in strategic policy development, counter narratives, disengagement and de-radicalisation programmes as well as media training in Afghanistan and across East and West Africa. She previously spent 20 years as a senior news correspondent and defence specialist, reporting for UK national newspapers on international and domestic fronts. She has extensive experience in conflict zones, specialising in CVE, defence, legal and human rights issues.



## **Aidan White**

**Aidan White** is the Director of the Ethical Journalism Network (EJN), the global organisation of the world's major media professional groups which promotes ethics, good governance and self-regulation of journalism across all media platforms. White has worked on numerous publications including *The Guardian* and the *Financial Times* and for 24 years was General Secretary of the International Federation of Journalists, during which time he helped create the world's largest organisation of journalists with members in 126 countries. He founded the EJN in 2012 and today the Network has more than 60 members and supports programmes to strengthen journalism in the Middle East, South Eastern Europe, Africa and Asia.



#### **Jean-Paul Marthoz**

**Jean-Paul Marthoz** is a journalist, a foreign affairs columnist at the Brussels daily Le Soir, a frequent guest to Belgian public broadcaster RTBF and Paris-based TV5. He is a member of the Europe Advisory Committee of the Committee to Protect Journalists (CPJ, New York), vice-chair of the Advisory Committee of Human Rights Watch's Europe and Central Asia division, member of the editorial board of Index of Censorship magazine (London) and on the Advisory Board of the Ethical Journalism Network (EJN, London).

Jean-Paul Marthoz has been foreign editor and editorial page director of Le Soir (1980-1991), director of the Media for democracy Program at the International Federation of Journalists (1992-95), European press director of Human Rights Watch (1996-2006), editorial director of the foreign affairs quarterly Enjeux internationaux (2003-2008), and EU correspondent of the Committee to Protect Journalists (2010-2017).

He is the author or coauthor of some 20 books on journalism, human rights and international relations as well as of a number of manuals on international reporting, including Terrorism and the Media (UNESCO, 2017).

He also teaches international journalism at the Université Catholique de Louvain (UCL, Belgium) and lectures regularly at a number of other institutions (CERAH-Geneva, EIUC Venice, etc.)



## Denis Džidić, moderator

**Denis Džidić** joined the Balkan Investigative Reporting Network in Bosnia and Herzegovina in August 2008, and is currently editor in chief of Detektor.ba and a journalist for the Balkan Transitional Justice programme. Prior to BIRN, Denis worked as a journalist for the Institute for War and Peace Reporting and the monthly youth magazine Rez, where he reported on young people and war crimes issues. Denis has worked as a journalist since 2006. He graduated from the Journalism Department of the Faculty of Political Science in Sarajevo and received his master's degree from the American University in BiH.

#### Muhamed Jusić

**Muhamed Jusić** is a journalist, interpreter and publicist as well as an analyst of Middle East and Balkans affairs, author and co-author of a number of books and studies on Arabic world and Islam, columnist for Al-Jazeera Balkans and for papers and magazines, such as *Start BiH*, *Oslobođenje* and *Preporod*. He has also authored a number of studies on violent extremism and foreign fighters phenomena, including two studies co-authored with Prof Vlado Azinović – The Lure of the Syrian War: the Foreign Fighters' Bosnian Contingent, and The New Lure of the Syrian War: the Foreign Fighters' Bosnian Contingent.

He is a correspondent for the Sarajevo Centre for Advanced Studies and co-ordinator of the *Islam in South East Europe* Project. Co-founder and co-ordinator of a non-governmental "Investigative Network - Islam in Southeast Europe" that gathers distinguished experts in this area.



### Vlado Azinović

**Dr. Vlado Azinović**, Associate Professor at the Department of Peace and Security Studies, School of Political Science, University of Sarajevo, Bosnia and Herzegovina. He has received his Ph.D. in Political Science from the American University of London (UK) and MA in International Relations from Norwich University (USA). Between 1995 and 2008 he worked as a senior editor at the Balkan Service, Radio Free Europe/Radio Liberty, Prague (Czech Republic).

Azinović is the author or co-author of Mapping Online Extremism in Bosnia and Herzegovina: Findings and Reflections (2018); Understanding Violent Extremism In The Western Balkan, Regional Report, Western Balkans Extremism Research Forum (2018), A Waiting Game - Assessing and Responding to the Threat from Returning Foreign Fighters in the Western Balkans (2018), Between Salvation and Terror: Radicalization and FTF phenomenon in the Western Balkans (2017), "The geostrategic aspects of jihadist radicalisation in the Western Balkans," in The Challenge of Jihadist Radicalization in Europe and Beyond, European Policy Center (2017); The New Lure of the Syrian War: The Foreign Fighters' Bosnian Contingent (2016), Bosnia and Herzegovina and the Nexus with Islamist Extremism (2015); The Lure of the Syrian War: The Foreign Fighters' Bosnian Contingent (2015); "Bosnia and Herzegovina and Terrorism 1996-2011: Defining the Threat, Devising Counterterrorism Strategy" in John J. Le Beau (editor) The Dangerous Landscape; International Perspectives on Twenty-First Century Terrorism (2013), Introduction to the Studies of Terrorism (2012); Assessing the Potential for the Renewed Ethnic Conflict in Bosnia and Herzegovina: A Security Risk Analysis (2011), Al Qaeda in Bosnia and Herzegovina: Myth or Present Danger? (2007), as well as book chapters, articles, essays and reviews on terrorism-related issues.

Dr. Azinović has served as an expert witness for the State Prosecutors' in terrorism-related cases tried before the Court of Bosnia and Herzegovina. He is also the UN consultant on CVE activities and projects, and a serving member of the Partnership for Peace Consortium of Defense Academies and Security Studies Institutes (Counter-Terrorism Working Group), and Radicalization Awareness Network (RAN). Dr. Azinović is the co-founder and Secretary General of the Atlantic Initiative in Bosnia and Herzegovina.



## Marija Ristić

**Marija Ristić** is the regional director of Balkan Investigative Reporting Network. She started working for BIRN in 2011 as a journalist, contributing to the regional Balkan Transitional Justice programme. Topics related to facing the past, reconciliation and transitional justice have been at the core of her professional development. After becoming the programme's director, Ristic was responsible for building the capacities of local media and civil society in order to promote reconciliation and intercultural dialogue.

She also made BIRN one of the first media organisations in the Western Balkans to initiate regular reporting about violent extremism, populism and propaganda under the regional Resonant Voices Initiative, which also involved training journalists to cover these topics.

Ristić is a graduate of the Geneva Academy for International Humanitarian Law and Human Rights. She has received numerous awards and scholarships from the Konrad Adenauer Stiftung, the OSCE, the Zoran Djindjic Foundation and the Research Council of Norway. She is also a fellow at the Free University in Berlin researching universal jurisdiction. In 2015, she produced the award-winning documentary 'The Unidentified'.



# **Igor Tabak**

Igor Tabak has been writing about military topics since the early 1990. He comments defence affairs in Croatia and the region, and also comments foreign policy affairs, primarily connected to wars, peacekeeping missions, NATO and EU. In addition to regularly co-operating with almost all media outlets in Croatia and in the region, Igor provides comments for world's major media outlets, such as BBC, Reuters, Washington Post and New York Times. He has been very active lately in terms of publishing articles on his own online portal "OBRIS – Defence and Security".

He is a member of the International Institute for Strategic Studies (IISS) in Great Britain, and he writes for its specialised military-intelligence company under the name *Jane's*.



## Tanja Šuković

Tanja Šuković started her journalist career at TVCG, in late 1989. She worked as a journalist, reporter, news editor, "Pečat" TV Magazine editor, documentary programme editor. She also worked for the first Montenegran independent radio station 'AntenaM', co-operated occasionally with TV Yutel and weekly show 'Monitor'. Tanja Šuković authored numerous documentaries and stories. She finished elementary and secondary education in Titograd and graduated from the Faculty of Philosophy in Belgrade, Psychology Department.



## **Adnan Rondić**, moderator

**Adnan Rondić** is a TV journalist, and has been in journalism since 1992. He started his career at the Hayat TV, and worked as a Voice of America correspondent from BiH for ten years. Since 2011, he has been working for Al-Jazeera Balkans. He has also been working for more than ten years now, as a media appearance trainer. He is the author of the study called "Return between Illusion and Reality", published by the Friedrich Ebert Stiftung (2007).

He received his degree in Communicology and master's degree in Political Sciences at the Faculty of Political Sciences in Sarajevo, where he has been a Ph.D. candidate since 2012 at the interdisciplinary doctoral study.

### **Andrew MacDowall**

**Andrew MacDowall** is a correspondent and analyst focusing on Central and Eastern Europe. He writes about politics, business and economics in Turkey, the Middle East, and South East Asia for publications including the Financial Times, the Guardian, Politico Europe, Christian Science Monitor, and Business New Europe.

He has interviewed hundreds of figures, including Prime Ministers, tycoons, and war veterans. Andrew also undertakes consultancy work for investors in CEE and beyond, and is a regular speaker and moderator at conferences in the region.

He has lived and worked in CEE since 2006. He was educated at the University of Cambridge and has a postgraduate diploma in newspaper journalism from London's City University.

Daria Šito-Sučić has been a Reuters correspondent from Bosnia since 1997, reporting on a wide range of topics, including politics, economy, social issues but also entertainment and sports. She covered the post-war reconstruction efforts in Bosnia, returns of refugees, numerous elections, the role of the international organisations involved in the rebuilding of the country, security, war crimes and issues affecting all spheres of life in Bosnia. She also reports on economics and politics in other countries of the region, including Slovenia, Croatia, Montenegro and Macedonia.

From 1995-1997, Daria worked as a research analyst in the Open Media Research Institute in Prague, covering developments in Bosnia and Croatia. She also wrote for the Prague-based Transitions Online.

Daria holds a B.A. in the Serbo-Croat language and Yugoslav Literatures from the University of Sarajevo School of Arts and Letters, and M.A. in social and political studies from the Lancaster University, earned at the Central European University, Prague College.



# Amela Odobašić, moderator

**Ms. Amela Odobašić** heads the Public Affairs Division of Communications Regulatory Agency of Bosnia and Herzegovina since 2001., the first converged regulatory authority for broadcasting and telecommunications established in the Western Balkans. She also works as a communications and regulations specialist nationally and internationally. Some of the countries she worked in include Iraq, Afghanistan, Somalia, Kenya, as well as those of the Western Balkans.

Besides, on behalf of Bosnia and Herzegovina, Amela acts as Vice-Chair of the Study Group 1 and rapporteur for the question on access to telecommunications /ICT Services by persons with disabilities and other persons with specific needs of the International Telecommunications Union.

She holds a B.A. (Hons) English obtained at the Kingston University (UK) as well as Diploma in Public Relations obtained at the Charted Institute of Public Relations in London (UK).

#### **Alaister Reed**

**Dr Alastair Reed** is a Senior Research Fellow at the International Centre for Counter-Terrorism (ICCT) and Leiden University, in the Netherlands. His main research interests are foreign fighters, radicalization, terrorist and insurgent strategy, propaganda and strategic communications. His current area of focus is on understanding and responding to terrorist propaganda, for which he set-up and leads the Counter-Terrorism Strategic Communications project - a collaborative research project that has brought together top researchers in the field from across the world.

He is also an Associate Fellow at the Kings' Centre for Strategic Communications (KCSC) at KCL department of War Studies.



### Leila Turčilo

**Lejla Turčilo** is a Professor at the Department of Journalism/Communicology of the Faculty of Political Sciences of Sarajevo University, where she teaches General Communicology, Media Theory, Media and Politics, Online Journalism and TV Journalism courses.

She authored the following books: "(P)Ogledi o medijima i društvu: članci, eseji, istraživanja" (Perception of the Media in Society: Articles, Essays and Research Papers), "Zaradi pa vladaj: politika-mediji-biznis u globalnom društvu i u BiH" (Make Money and Rule: Politics, Media and Business in Global Society and BiH), Online komunikacija i offline politika u BiH, (Online Communication and Offline Politics in BiH), in addition to co-authoring the following books: "Mladi, politika i mediji: priručnik za razvijanje političke i medijske pismenosti mladih" (Youth, Politics and Media: Manual for Development of Political and media Literacy of Youth), "Mediji i shrinking space u BiH: utišani alternativni glasovi" (Media and Shrinking Space in BiH: Silenced Alternative Voices), "Informacijska pismenost-smjernice za razvoj mrežnih modula" (Information Literacy – Guidelines for Development of Network Modules).

She also wrote reports on the subject of media literacy situation in BiH in 2014, as a part of the project under the title: "Media Literacy Mapping in Europe", sponsored by the French Sorbonne University. She published over 30 papers in Bosnia and Herzegovina, Serbia, Croatia, Montenegro, France, Belgium, Germany, USA and Columbia.

She earned her BA, MA and PhD degrees at the Faculty of Political Sciences of Sarajevo University.



## **Ludovica Di Giorgi**

**Ludovica Di Giorgi** is a Manager at Moonshot CVE, where she leads work in North America, Southeast Asia and the Western Balkans. She currently leads Moonshot CVE work on the violent far right, and has recently been published on the topics of radicalisation, gender and human rights, mostly focusing on the MENA region and Asia.

Bosnia and Herzegovina

Her experience ranges from capacity building to running global counternarrative campaigns focusing on jihadism and the violent far right, and has more than 10 years of experience in training volunteers on how to handle individuals with varying special needs.

Ludovica graduated with honours from Lancaster University, where she was the recipient of the Joan Wardman Peace Prize for best contributions to work on Peace Studies.



## **Vlado Azinović,** moderator

**Dr. Vlado Azinović**, Associate Professor at the Department of Peace and Security Studies, School of Political Science, University of Sarajevo, Bosnia and Herzegovina.
