The 22nd Meeting of the OSCE Ministerial Council will be held in Belgrade on 3 and 4 December 2015 at the Kombank Arena, located at Blvd. Arsenija Čarnojevića 58, 11070 Novi Beograd, Serbia. The official website of the Kombank Arena is www.kombankarena.rs.

Liaison Officers

Each delegation will have at least one designated Liaison Officer, available from Monday, 30 November to Saturday, 5 December 2015.

Head of Delegation (HoD) and Members of Delegations (MoD) travelling with HoD will be met by a Liaison Officer upon arrival at Nikola Tesla Airport or at the border crossing point if arriving by car.

Welcome and Information desks will be set at Nikola Tesla Airport as well as in all official hotels, to provide assistance and logistical support to delegates.

The Kombank Arena can only be accessed with a valid accreditation badge, which will be distributed to delegates by designated Liaison Officer upon their arrival. Delegates and media representatives might be requested to present proof of identity (passport or national ID card) at any time.

The cash point / exchange office is located at the Kombank Arena, Level 100, next to the Delegates' entrance.

Another cash point/exchange office will be available at the entrance of Palace "Srbija" (location of Delegates' restaurant).

Security

To gain entry to the Kombank Arena while inside the building, a valid ID badge or pin must be worn and

visible at all times. In addition, delegates are requested to cooperate with security check points and to follow the directions of the police, security and protocol staff at all times. Security staff will ensure that visitors only enter areas that they are permitted to enter.

Delegates should be aware that airport-style x-ray screening will be used at the Kombank Arena (with exception for HoD).

Arrival and Departure

BY PLANE

Belgrade is located in the heart of Europe and there are direct flights to and from Nikola Tesla Airport, connecting the city worldwide. That is why delegations are advised to arrange their arrivals on one of many regular commercial flights.

Upon arrival, delegations are advised to proceed to the OSCE MC2015 Welcome and Information desks at the Nikola Tesla Airport located within the transit zone and in the Baggage Claim Area, as well as after customs control exit at the Airport. A separate passport control booth will be assigned for OSCE MC2015 participants.

Transportation from the Nikola Tesla Airport to official hotels is provided by shuttle buses.

BY CAR

Each Head of Delegation arriving by car will be provided with police escort and guided from the border crossing point to the Hotel / Kombank Arena.

ARRIVAL HEADS OF DELEGATIONS / DELEGATES

Heads of Delegations arriving on government or private aircraft will be greeted at the plane by representative of MFA of the Republic of Serbia, Liaison Officer and no more than one diplomat from their embassy and will be transferred directly from the plane to the VIP lounge. After necessary procedures are completed they will be transported to their hotel.

Heads of Delegations arriving by commercial flight will be greeted at the tarmac/gate by representative of MFA of the Republic of Serbia, representative of Protocol and no more than one diplomat from their embassy and will be escorted by the airport VIP services to the VIP lounge/ business lounge. Further details will be communicated directly upon arrival.

After necessary procedures are completed they will be transported to their hotel.

Delegates arriving prior to the HoD will be transferred by shuttle buses. A transport system for all OSCE delegations will be in place from Monday 30 November 2015 to Saturday 5 December 2015. Shuttle services will be available between Nikola Tesla Airport, designated hotels and Kombank Arena.

Also, delegate's badges will allow free access to public transportation within the city of Belgrade from 30 November to 5 December 2015.

BAGGAGE TAGS

Delegations are requested to mark their baggage using the OSCE baggage tags.

Checked in baggage of the HoD and MoD arriving together will be collected by Protocol / Liaison Officer.

Checked in baggage of MoD arriving separately from HoD will be delivered at OSCE assigned carousel, regardless of the arrival flight, at the baggage claim area, and collected personally.

DEPARTURES

HoD and MoD departing by commercial flights are advised to arrive at the airport at least 70 minutes before scheduled departure.

The Heads of Delegations will be escorted to the airport VIP lounge/Business lounge prior to departure, accompanied by Protocol and Liaison Officer.

Journalists departing with HoD by special flights are required to be at the VIP lounge 45 minutes before the flight.

CUSTOMS

Please be aware that customs officers will monitor the areas and may operate checkups.

HAND BAGGAGE REGULATIONS

Aviation security regulations prohibit all passengers from carrying any liquid, gels or pastes of more than 100mls through security screening. Containers of 100mls or less of liquids, gels, pastes, lotions and cosmetics may be brought through the passenger security screening point in a transparent re-sealable bag of no more than one liter capacity, 20cm x 20cm.

The rules apply to all liquids/gels/pastes such as water and beverages, aerosol cans and toiletries such as toothpaste, shaving cream, hair gel, lip-gloss and creams. There is a limit of one transparent plastic bag per person.

Medicines required during the flight are exempt from this rule, but must be placed in a separate transparent re-sealable bag and presented separately at the passenger screening area.

VISAS

Delegates requiring an entry visa must submit their request to Serbian embassy or consulate.

Visas are issued free of charge for all Members of official Delegations.

Those in possession of a valid Schengen, UK or USA visa or a valid residence permit issued by a Schengen member state, the UK or the USA in their passport (not travel document) are exempt from visa requirements.

The visa requirement exemption applies only to holders of biometric passports.

Transportation

HEADS OF DELEGATIONS

Heads of Delegations will be provided with a car and driver during the Ministerial Council. This service is exclusively reserved for use by the HoD and can accommodate a maximum of one more delegation member.

This service will be available - from and to Nikola Tesla Airport - from the time of arrival (earliest 2 December 2015) until departure (latest 5 December 2015).

DELEGATION TRANSPORT

A transport system for all OSCE delegations will be in place prior to and during the OSCE Ministerial Council, from Monday 30 November 2015 to Saturday 5 December 2015.

All delegates have free access to public transport within the City of Belgrade from 30 November to 5 December 2015. Liaison Officers will be tasked and ready to assist delegates with inquiries regarding public transport.

Shuttle services will be available between Nikola Tesla Airport, Hotels and Kombank Arena.

From Wednesday 2 December to Saturday 5 December 2015, each delegation with more than two people, including HoD, will have a car/minibus and driver at their disposal. Minibuses/cars are to be used exclusively for OSCE Ministerial purposes.

ARRIVAL BY CAR

In order to have access to the security perimeter and to the secured parking area of the Kombank Arena, delegations have to apply for the registration of their vehicle. If the registration has not been completed before arrival, delegations have to report to the Accreditation Desk located at the Hotel IN.

General Information about Serbia

CURRENCY

Serbia's official currency is the Serbian dinar (RSD). The smallest coin in use is 1 RSD. Dinar Exchange Rate can be found at http://www.nbs.rs/export/sites/default/internet/english/scripts/kl_srednji.html.

SHOPS

Shops are open from Monday to Saturday from 8:00 am to 8:00 pm, on Sundays most shops are working from 8:00 am to 4:00 pm.

BANKS AND CREDIT CARDS

Banks are open from Monday to Friday 8:30 am to 5:00 pm. Almost all banks have automated teller machines (ATMs) that accept overseas bank cards and are accessible from outside (look for "Bancomat"). Please check with your local bank before departure whether your bank card is valid in Serbia.

Credit cards, such as Maestro, Master Card, Visa and American Express are generally accepted in Serbia.

ELECTRICITY SUPPLY

The electric current used throughout Serbia is 230 Volts AC, 50 Hz (continental European standard).

This two-wire plug is ungrounded and has two round prongs. It is popularly known as the Europlug. The plug has two 4 mm round pins, measuring 19 mm in length on centers spaced 18.6 mm apart at the base and 17.5 mm apart at the tip. The two pins have 10 mm long insulated sleeves. They converge slightly, but they are relatively flexible which allows the plug to mate with any socket that accepts 4.0 – 4.8 mm round contacts on 17.5 – 19 mm centers. The plug is generally limited for use in class II applications that require 2.5 amps or less. It is commonly

used in all countries of Europe except in the United Kingdom, Ireland, Cyprus and Malta.

Adaptors for other plugs are available in most hotels. Please note that German / French / Austrian plugs with thick pins (diameter 4.8 mm [1/5 inch]) and Italian plugs with three thin pins in a row are not compatible with Serbian wall outlets, despite the equal distance of their two main pins.

CLIMATE

In December, the average minimum temperature in Belgrade is 0°C and the average maximum temperature is 6°C.
