DECISION N_0 . 1211 TERMS OF REFERENCE OF THE OSCE AUDIT COMMITTEE

The Permanent Council,

Determined to further strengthen internal and external control mechanisms which are essential for ensuring effective and efficient management of the OSCE,

Taking note of the recommendations of the OSCE Audit Committee and External Auditors regarding further improvement of management in the OSCE,

Recalling that the Terms of Reference of the OSCE Audit Committee, as established by Permanent Council Decision No. 1024 and extended by its Decision No. 1161, can be revised by the Permanent Council as necessary,

Decides to approve the amended Terms of Reference of the OSCE Audit Committee as contained in the annex.

OSCE AUDIT COMMITTEE TERMS OF REFERENCE

1. Guiding principle

An Audit Committee shall be established by the Permanent Council to exercise an independent appraisal function, providing the participating States with assurances that the Organization's controls are in place and operating properly. It shall perform this function through independent reviews of the work carried out by the OSCE's system of internal and external controls, including Internal Oversight, the External Auditors and the administration and management of the Organization. It shall also advise the Secretary General in his capacity as Chief Administrative Officer. The work of the Audit Committee shall be conducted in accordance with internationally accepted best practices and in compliance with OSCE policies, rules and regulations.

2. Role of the Committee

The Committee shall:

- (i) Review and monitor the adequacy, efficiency and effectiveness of the Organization's system of internal and external controls, including OSCE internal oversight functions, the external auditor functions and the implementation of audit recommendations;
- (ii) Have the opportunity to present its views to the participating States on the results of the External Auditor's audit of the Organization's financial statements;
- (iii) Have the opportunity to present its views to the Secretary General on the appointment or termination of the assignment of the Director of Internal Oversight within the scope of the OSCE Staff Regulations and Staff Rules and prior to appointment or termination action being taken. In this regard, the Secretary General shall consult the members of the Audit Committee on the short-listing of candidates for the Director, OIO position and may appoint Audit Committee members to the interview panel, in consultation with the Chairperson of the Committee. The Audit Committee may convene a special meeting for the purpose of advising the Secretary General on these matters;
- (iv) Advise the Secretary General as the Chief Administrative Officer on all policy issues related to the system of internal and external controls and its performance;
- (v) Report to the Permanent Council, through the Advisory Committee on Management and Finance, in particular on any matters of policy requiring corrective action and improvements in the area of controls, including appraisal, audit, investigation and risk management.

3. Membership of the Committee

The Committee shall be composed of three members who shall be senior audit professionals of high standing in the international audit community, fully independent of the OSCE, and with no affiliation with national governments of the OSCE participating States. The Chairmanship-in-Office, in consultation with participating States, shall appoint the members of the Committee. Each member shall serve as Chairperson of the Committee for one year on a rotational basis.

4. Terms of appointment

The members shall serve for terms of three years, extendable for a further period of one year.

5. Rules and procedures

The Audit Committee shall meet for its regular sessions at least twice a year. A minimum of two members shall constitute the quorum. Additional meetings may also be scheduled on an ad hoc basis as necessary. The Chairperson of the Committee shall determine the timing of meetings and the need for any additional meetings in the course of the year. He/she shall also set the agenda of the meetings, taking into account relevant requests of the Permanent Council. The Audit Committee shall be able to call upon OSCE officials and request meetings with other parties as it deems necessary to obtain information relevant to its work. In particular, the Office of Internal Oversight and the External Auditors shall be readily available to respond to inquiries and make presentations to the Committee.

The Audit Committee shall adopt recommendations on a consensus basis. In case of dissent among Committee members, the conclusions of the Chairperson in charge of the meeting, together with the dissenting opinion, shall be presented in the subsequent Committee report.

6. Independence

In performing their functions, the members of the Committee shall neither seek nor receive instructions from any government authorities. They shall act fully independently from any individual OSCE bodies and structures, and shall be guided solely by their expertise and professional judgement, taking into account the collective decisions of the OSCE governing bodies.

For a candidate member to be considered "independent" for the purpose of this section, he/she must be independent in character and judgment. A candidate will not be considered as meeting the independence requirement if he/she has entered into any consulting, advisory or other compensatory contract with the Organization within the past 12 months, or has an immediate family member who is or has been a senior staff member (P5 or above) of OSCE within the last three years. Audit Committee members shall not be eligible for any form of employment with the OSCE for at least 12 months immediately following the last day of their tenure on the Committee.

Access to documents

The Audit Committee shall have access to all records and documents of the Organization, including audit reports, investigations, and work documents of the Office of Internal Oversight and the External Auditors. Committee members shall sign non-disclosure statements at the beginning of their tenure.

8. Reporting

- The Audit Committee shall submit an annual report to the Permanent Council. (i)
- (ii) The Audit Committee may also submit ad hoc reports to the Permanent Council as necessary.
- The Secretary General shall be given the opportunity to comment on all reports prior (iii) to their submission. Comments of the Secretary General, which he/she deems necessary, shall be incorporated in the relevant reports.

9. Resources

The Audit Committee shall be provided with such resources as necessary to undertake its duties. Funds shall be included annually in the Unified Budget proposal to provide exclusively for the travel and accommodation costs of the members of the Committee, in accordance with OSCE administrative rules and regulations. The members shall serve without remuneration from the OSCE. The Audit Committee shall also be provided with funds for temporary administrative and secretarial support.

10. Time limit

These Terms of Reference will be in effect for three years after approval by the Permanent Council, and will be revised thereafter as necessary.

DECISION No. 1212 EXTENSION OF THE DEPLOYMENT OF OSCE OBSERVERS TO TWO RUSSIAN CHECKPOINTS ON THE RUSSIAN-UKRAINIAN BORDER

The Permanent Council,

Recalling its Decision No. 1130 of 24 July 2014 on the deployment of OSCE observers to two Russian checkpoints on the Russian-Ukrainian border (PC.DEC/1130),

Decides:

- 1. To extend the mandate of the deployment of OSCE observers to the two Russian border checkpoints of Donetsk and Gukovo on the Russian-Ukrainian border until 31 October 2016;
- 2. To approve the arrangements and the financial and human resources for the Observer Mission as contained in document PC.ACMF/32/16. In this respect, authorizes the use of 311,100 euros from the provisional 2014 cash surplus to fund the proposed budget for the duration of the mandate to 31 October 2016.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

The delegation of Slovakia, in its capacity as EU Presidency, passed the floor to the representative of the European Union, who delivered the following statement:

"In connection with the decision of the Permanent Council on the extension of the deployment of OSCE observers to two Russian checkpoints on the Ukrainian-Russian State border, the European Union would like to make the following interpretative statement under the relevant provisions of the Rules of Procedure:

The European Union's views on the vital importance of border monitoring on the Russian-Ukrainian State border are well-known. Effective and comprehensive monitoring of this border is an integral part of a sustainable political solution in line with OSCE principles and commitments, which re-establishes full Ukrainian control over its sovereign territory, including the border. We recall that the Minsk Protocol calls for permanent monitoring of the border and verification by the OSCE and that the Minsk Package of Measures includes a commitment to reinstate full Ukrainian control over its entire international border.

The OSCE Observer Mission's currently very limited mandate and its small size does not provide for a comprehensive border monitoring. We therefore reiterate our call for a significant expansion of the Observer Mission to all border crossings on the Russia-Ukraine State border currently not under control of the Ukrainian Government as well as monitoring between these border crossings. This should be supported and co-ordinated with border monitoring on the Ukrainian side of the border by the Special Monitoring Mission and we reiterate the need for the SMM to be assured safe and unhindered access to all parts of the border currently not under Ukrainian Government control since border and ceasefire monitoring are very closely interlinked. Further we underline the need for sufficient equipment for the Observer Mission in order to monitor movements on the border more effectively.

We regret that the Russian Federation continues to resists an expansion of the Observer Mission."

By the delegation of the United States of America:

"In connection with the adoption of the decision for the extension of deployment of OSCE observers to two Russian checkpoints on the Russian-Ukrainian border, the United States would like to make the following interpretative statement under paragraph IV.1(A)6 of the OSCE Rules of Procedure:

The United States finds it deeply regrettable that the Russian Federation continues to block the expansion of the geographic scope of the Observer Mission, despite the clear, strong, and continued support from other participating States to do so. We once again must accept an inadequate, limited-scope mission covering just two border checkpoints, which together account for only a few hundred meters of the 2,300 kilometre Ukrainian-Russian border, much of which Ukraine does not control.

Due to Russia's unwarranted restrictions of the border Observer Mission's work, the Mission will continue to be unable to ascertain the full extent to which Russia is participating in or facilitating the flow of arms, funding, and personnel to support the separatists in eastern Ukraine.

We note that Point 4 of the Minsk Protocol delineates a clear role for the OSCE to monitor and verify both sides of the Ukrainian-Russian international border, and to create a security zone in the border areas of Russia and Ukraine. There are strong linkages between ceasefire monitoring and border monitoring, and it is to the detriment of all efforts to resolve the conflict that the OSCE approach to these activities has been impeded by one participating State. The Russian Federation's repeated refusal to allow expansion of the scope of this mission shows, once again, that it refuses to fulfil its Minsk commitments.

I request that this interpretative statement be attached to the decision and to the journal of the day.

"Mr. Chairperson,

In connection with the Permanent Council decision on the extension of the deployment of OSCE observers to two Russian checkpoints on the Russian-Ukrainian border, the delegation of Ukraine would like to make the following interpretative statement under paragraph IV.1(A)6 of the Rules of Procedure of the Organization for Security and Co-operation in Europe.

The delegation of Ukraine reiterates the importance of substantial and broad OSCE monitoring on the Russian side of the Ukrainian-Russian border in zones adjacent to the certain areas of Donetsk and Luhansk regions of Ukraine.

Having signed the Minsk Protocol of 5 September 2014, all signatories, including the Russian Federation, undertook to ensure permanent monitoring of the Ukrainian-Russian State border and its verification by the OSCE with the establishment of a security zone in the border areas of Ukraine and the Russian Federation.

Expanding the mandate of the OSCE Observer Mission at the Russian checkpoints 'Gukovo' and 'Donetsk' to all sections of the border adjacent to certain areas of the Donetsk and Luhansk regions is to be part of implementation of the agreement already reached and is critical for sustainable de-escalation and peaceful resolution of the conflict in Donbas.

We regret that the Russian Federation objects to the expansion of the mandate of the OSCE Observer Mission at the Russian checkpoints 'Gukovo' and 'Donetsk' to all sections of the border that is temporarily not under control of the Ukrainian authorities.

Such persistent reluctance on the part of Russia can only be attributed to its unchanged intention to continue intervention in Ukraine's Donbas, including by sending heavy weapons, military equipment, regular troops, fighters and mercenaries, sponsoring the terrorist activities in the territory of Ukraine. As repeatedly emphasized in the formal communications of the Ministry of Foreign Affairs of Ukraine to the Ministry of Foreign Affairs of the Russian Federation, these actions by Russia constitute internationally wrongful acts, which entail international responsibility. We continue to urge Russia to immediately cease these acts.

We call upon the Russian Federation to demonstrate its full commitment to the implementation of the Minsk agreements in good faith and to allow proper and comprehensive permanent monitoring by the OSCE and establishment of a security zone on the Russian side of the Ukrainian-Russian State border adjacent to the areas in Donbas which presently are not controlled by the authorities of Ukraine.

The delegation of Ukraine requests that this statement be attached to the decision and registered in the journal of the day.

INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

By the delegation of the Russian Federation:

"The Russian Federation joined the consensus regarding the Permanent Council decision on the extension of the mandate of the team of OSCE observers at the two Russian checkpoints of Gukovo and Donetsk on the Russian-Ukrainian border for three months until 31 October 2016, regarding the work of this team as an additional confidence-building measure in the settlement of the internal Ukrainian conflict.

We reaffirm that the places of deployment and functions of the team of OSCE observers are clearly defined by the team's mandate approved by Permanent Council Decision No. 1130 of 24 July 2014, which is based on the invitation of the Russian Federation of 14 July 2014 made in the wake of the Berlin Declaration of the Foreign Ministers of Russia, Germany, France and Ukraine of 2 July 2014.

The Minsk Protocol of 5 September 2014 does not mention the deployment of OSCE observers on the Russian side of the border with Ukraine. Nor is there any reference to this in the Package of Measures for the Implementation of the Minsk Agreements adopted on 12 February 2015 and subsequently endorsed by United Nations Security Council resolution 2202. The decision to allow OSCE observers on Russian territory and the presence of Ukrainian border guards and customs officers at Russian checkpoints in the absence of a full-scale peace settlement are solely a goodwill gesture on Russia's part.

I request that this statement be appended to the decision adopted, and included in the journal of the day."
