STATEMENT BY THE DELEGATION OF ANDORRA

Madam Chairperson,

I should like first of all to congratulate you on your recent assumption of the Chairmanship and to wish you every success.

At the commencement of Andorra's Chairmanship of the Forum for Security Co-operation (FSC), our Minister for Foreign Affairs, Mr. Juli Minoves, expressed the wish to make a voluntary contribution to projects to eliminate stockpiles of conventional ammunition.

This wish has now taken form; and today it gives me pleasure to announce to the FSC that at its general session of 13 September 2006 the Parliament of the Principality of Andorra approved a voluntary contribution to the current OSCE programme on small arms and light weapons and conventional ammunition stockpiled in Tajikistan.

Andorra will contribute 20,000 euros to phase II, task 1, of the programme, which is aimed at the disposal of conventional ammunition and specifically of rocket boosters.

By making this contribution, Andorra shows its commitment to the FSC's efforts to promote peace, stability and security and, at the same time, expresses our solidarity and support for initiatives by the international community against arms and in favour of peace.

During Andorra's Chairmanship of the FSC, my minister, Mr. Minoves, presented it with a CD by the singer Pete Seeger containing a song entitled "Andorra", which said: "I want to go to Andorra, it's a place I adore. They spent four dollars and ninety cents on armaments and their defence." Today our defence budget is still the same, while our budget for development aid and co-operation continues to grow.

I would request, Madam Chairperson, that you attach this statement to the journal of the day.
