TIMING OF A DEMONSTRATION OF NEW TYPES OF MAJOR
WEAPON AND EQUIPMENT SYSTEMS**

The Forum for Security Co-operation (FSC),

Reaffirming that the OSCE Vienna Document 1999 remains a key instrument for confidence- and security-building measures (CSBMs) and noting the determination of the participating States to update, as necessary, and revise the Vienna Document 1999 with particular attention to strengthening current CSBM instruments,

Seeking to update the Vienna Document 1999 in accordance with the principles delineated in Decision No. 1/10 on establishing a procedure for incorporating relevant FSC decisions into the Vienna Document, FSC.DEC/1/10 of 19 May 2010,

Taking into account Decision No. 7/10 on negotiations on the Vienna Document 1999, FSC.DEC/7/10 of 29 September 2010, emphasizing the importance of a mechanism for regular updates of the Vienna Document,

Decides to amend paragraph (31) of Chapter IV, Demonstration of New Types of Major Weapon and Equipment Systems to read as follows:

(31) The first participating State which deploys with its military forces in the zone of application a new type of major weapon and equipment system as specified in the provisions on Information on Military Forces will arrange at the earliest opportunity, but not later than one year after deployment has started, a demonstration for representatives of all other participating States², which may coincide with other events stipulated in this document. On exceptional bases, in order to facilitate the combination with other events, the participating States may organize the demonstration even before the formal deployment of the new type of major weapon and equipment system to their military forces, during any phase of the deployment process, pending physical availability.

Decides to:

Insert new paragraphs (+151) and (+152), both including subparagraphs, with the language from FSC Decision No. 1/10, in Chapter XII prior to the section entitled OSCE Communications Network as follows:

XII. FINAL PROVISIONS

UPDATING THE VIENNA DOCUMENT

(+151) Forum for Security Co-operation (FSC) decisions which update existing provisions of the Vienna Document should include the exact textual changes made to the Document and will be labelled as “Vienna Document Plus” (VD PLUS).

(+151.1) VD PLUS provisions decided upon by the FSC will supersede any equivalent existing VD provisions.

(+151.2) VD PLUS provisions decided upon by the FSC shall enter into force on the date of adoption unless it is otherwise specified in the text of the decision.

(+151.3) The OSCE Conflict Prevention Centre (CPC) will keep a record of all valid VD PLUS provisions.

(+152) Participating States will organize a special FSC meeting to take place every five calendar years or more frequently, as decided by the FSC, starting not later than in 2011 and taking into account the Annual Implementation Assessment Meeting, as appropriate, in order to reissue the Vienna Document, and;

(+152.1) Task the OSCE Secretariat within one month of the special FSC meeting with reissuing the Vienna Document labelled with the year of the revision.

II. Organizational modalities

Organization

The OSCE Workshop on Implementing UNSCR 1540 will take place on 27 and 28 January 2011 in Vienna.

Standard OSCE rules of procedure and working methods will be followed, *mutatis mutandis*, at the OSCE Workshop on Implementing UNSCR 1540.

A representative of the FSC Chairmanship (Iceland) will chair the opening and closing plenaries.

There will be four working sessions on the following topics: (1) Role of regional organizations; (2) Public-private partnerships; (3) End-use controls and border monitoring, and (4) United Nations Global Counter-Terrorism Strategy and proliferation of weapons of mass destruction, field missions, and best practice guides. The goal of the working sessions will be to identify recommendations for activities the OSCE could pursue in each of the specific areas. Each working session will be led by a moderator who is an expert in the particular area of focus of the session, and will have a rapporteur. The moderators may ask delegations for assistance in the preparation of the sessions.

Simultaneous interpretation into and from all six working languages of the OSCE will be provided at the opening, working and closing sessions.

The FSC Chairperson will provide a report on the Workshop not later than 1 April 2011.

Participation

Participating States or other external organizations are encouraged to ensure representation at the expert level in the OSCE Workshop on Implementing UNSCR 1540.

The OSCE institutions, Partners for Co-operation and Mediterranean Partners for Co-operation, as well as non-proliferation-related intergovernmental organizations, such as but not limited to the IAEA, OPCW and BWC ISU, will be invited to participate in the OSCE Workshop. Please see the appendix listing 1540-related organizations.

General guidelines for participants

The OSCE Workshop on Implementing UNSCR 1540 will be conducted in several sessions.

The working sessions will concentrate on major topics, in some cases introduced by keynote speakers, whose addresses will be followed by a discussion of any number of

relevant subtopics that delegates may wish to raise. The aim is to have an interactive and free-flowing discussion.

To promote interactive discussion, delegations are requested to provide formal statements in writing only. Prior circulation of statements and interventions will enhance the possibility for engaging in discussion.

Guidelines for keynote speakers

The contributions of keynote speakers should set the scene for the discussion in the sessions and should set the stage for substantive, focused and interactive discussion.

The maximum available speaking time is 10 minutes for each keynote speaker.

Keynote speakers should be present throughout the session at which they are speaking, and should be ready to engage in the debate following their presentation.

Guidelines for moderators

The moderator chairs the session and should facilitate and focus the dialogue among delegations. The moderator should stimulate the debate by introducing items related to the subject of the opening and working sessions, as appropriate, in order to broaden or focus the scope of the discussion.

Guidelines on the timing of submission and distribution of written contributions

Each keynote speaker should submit a written contribution no later than 19 January 2011.

Participating States and other participants in the Workshop are invited to submit any written contributions they may wish to present by 19 January 2011.

1. The OSCE Workshop will afford an opportunity for participating States to explore the possibilities for specific areas of work by the OSCE. Such activities might include, *inter alia*, (from SEC.GAL/107/10):

- Development of an OSCE handbook of best practice guides for implementation of UNSCR 1540, including:
 - Export controls and transshipment (FSC.DEC/7/09);
 - Practices prohibiting non-State actors from acquisition and use of WMD;
 - Effective accounting and security in respect of WMD materials;
 - Development of physical protection of WMD materials;
 - Establishment of border controls in relation to WMD materials;
- Provision of assistance to participating States for the development of national action plans and national legislation by the OSCE participating States and Partners for Co-operation;

- Establishment of internal co-operation and co-ordination among active participating States and within the Secretariat, with the aim of involving all the thematic units dealing with trans-border crime, border management, terrorism, trafficking, etc.;
- Assistance in the development of national implementation plans as a means for providing additional reporting and to strengthen national legislation;
- Awareness-raising;
- Practical assistance to participating States at their request;
- Training.

2. The following suggestions are from the letter of the Chairman of the UN Committee established pursuant to UNSCR resolution 1540, Mr. Jorge Urbina, to the United Kingdom Chairmanship of the OSCE Forum for Security Co-operation, dated 29 December 2009:

- Contribution by the OSCE to workshops on implementation of resolution 1540 organized by the UNODA;
- Joint capacity-building workshops in Central Asia and Eastern Europe that could be organized under the leading role of the OSCE;
- Possible contribution of the OSCE to events outside its region, including sharing with others its best practices and the experience of its members in the implementation of UNSCR 1540;
- Identification of other possibilities for co-operation between the OSCE and the 1540 Committee.
