The Helsinki Document of 1992 (Chapter IV) called for increasing the openness of OSCE activities and expanding the role of NGOs. In particular, in paragraph (15) of Chapter IV the participating States decided to facilitate during CSCE meetings informal discussion meetings between representatives of participating States and of NGOs, and to provide encouragement to NGOs organizing seminars on CSCE-related issues. In line with this decision, NGOs, governments, and other participants are encouraged to organize side meetings on relevant issues of their choice.

Title: The OSCE Chairmanship and Kazakhstan

Summary: At the 2007 Ministerial Council Meeting in Madrid, Kazakhstan's Foreign Minister promised the participating States that his country would implement far-reaching domestic reforms before assuming the chairmanship of the OSCE. At this event a group of leading Kazakhstani civil society activists will provide an analysis of the steps Kazakhstan's government has taken to date and the steps it still needs to take in order to fulfill those obligations. Presenters will include: Yevgeniy Zhovtis (Kazakhstan International Bureau on Human Rights), Ninel Fokina (Almaty Helsinki Committee), Tamara Kaleyeva (International Fund for the Defense of Freedom of Speech "Adil Soz"), Zhemis Turmagambetova (Charter for Human Rights), and Vera Tkachenko (Legal Policy Research Center).

Title: Secularism and the Rule of Law are a Guarantee of freedom of Religion or Belief

Summary: *“The OSCE human dimension goes much further in linking human rights with the institutional and political system of a state. In essence, OSCE states have agreed through their human dimension commitments that pluralistic democracy based on the rule of law is the only system of government suitable to guarantee human rights effectively”*. The European Humanist Federation welcomes this Supplementary Human Dimension Implementation Meeting on Freedom of Religion and Belief as a great opportunity both for checking the implementation of FoRB and for monitoring present trends in how to interpret Freedom of Religion or Belief because, like all political concepts, FoRB may be viewed differently according to the eyes of the viewer and to the context to which it is referred.

In this side-event the European Humanist Federation will endeavour to answer the following questions:

- Rights belong to human beings. Are the attempts at applying them also to religions and beliefs and to religious institutions and communities of faith and conviction justified?
- Can a state that is not secular genuinely guarantee Freedom of Religion or Belief? Can it offer equality and non-discrimination?

The delegation of the European Humanist Federation wishes to discuss the above issues with government and NGO representatives as well as with ODIHR officers in the light of the *“commitment to the rule of law and in the way it is formulated, as a concept based on the dignity of the human person and a system of rights through law/legal structures”*.
