


Daily Report 232/2019

1 October 2019¹

Summary

- Compared with the previous 24 hours, the SMM recorded fewer ceasefire violations in Donetsk region and a similar number of ceasefire violations in Luhansk region.
- Three firefighters sustained shrapnel injuries in Donetsk city's Petrovskyi district.
- Inside the Stanytsia Luhanska disengagement area, the SMM continued monitoring works to connect a temporary pedestrian bypass bridge to the broken section of the bridge.
- The SMM again saw a barbed wire and a tube of an unused rocket-propelled grenade inside the Zolote disengagement area. It again observed military presence inside the Petrivske disengagement area.
- The Mission observed weapons in violation of their respective withdrawal lines in government-controlled areas of Luhansk region.
- The SMM saw unexploded ordnance on the road between Popasna and Molodizhne.
- The SMM monitored adherence to the ceasefire to facilitate the operation of and repairs to essential civilian infrastructure, including repairs to water pipelines and power lines and to enable the drilling of water wells.
- Restrictions of the Mission's access continued, including at checkpoints of the armed formations near Petrivske, Verkhnoshyrokivske and Shevchenko.*





In Donetsk region, the SMM recorded fewer ceasefire violations, however, more explosions (about 170), compared with the <u>previous 24 hours</u> (about 125 explosions). The majority of ceasefire violations were recorded by the SMM camera at the entry-exit checkpoint in Pyshchevyk (government-controlled, 84km south of Donetsk) at a range of 2-5km south-south-east, south and south-south-west of the camera, by the SMM camera at the Donetsk Filtration Station (DFS) (15km north of Donetsk) at a range of 0.2-5km in southerly directions of the camera and in areas east and east-south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk).

In Luhansk region, the SMM recorded a similar number of ceasefire violations, however, more explosions (18) compared with the <u>previous 24 hours</u> (12 explosions). The majority of ceasefire violations were recorded at east-south-easterly directions of Popasna (government-controlled, 69km west of Luhansk).

Three firefighters injured due to shelling in Donetsk city

The SMM followed up on reports of three firefighters (men, 34, 32, and 36 years old) injured by shelling in the Trudivski area of Donetsk city's Petrovskyi district (non-governmentcontrolled, 15km south-west of Donetsk city centre) on 11 September. On 29 September, at a hospital in Donetsk city, the SMM saw a man (34 years old) with his left arm amputated below the elbow and his limb bandaged. The man told the SMM that in the afternoon of 11 September, while extinguishing a fire, a 30mm grenade launcher round had hit the hose he was holding and exploded, shattering his left forearm and injuring his two colleagues who stood behind him. On 30 September, a firefighter (32 years old) told the SMM over the phone that on 11 September, he was with two other colleagues, extinguishing a fire at 67 Mamina-Sybiriaka Street in the Trudivski area. When they heard bursts of small-arm fire, he said, all three took cover behind the wall of the house for about five minutes. While standing opposite of the burning house, he added, he heard an explosion and had felt sharp pain in two places on his back. On the same day, the SMM received the same information from the third firefighter (36 years old) who had also been injured in the incident. At the hospital, medical staff told the SMM that three firefighters were admitted on 11 September with shrapnel injuries, adding that one of them had his left arm amputated. At the fire station in Petrovskyi district, a man (20 years old) told the SMM that he had seen three firefighters injured on 11 September while extinguishing a fire caused by an incendiary device. The SMM could not visit the above-mentioned address in the Trudivski area due to security concerns.

Stanytsia Luhanska disengagement area

In the afternoon of 29 September, the SMM saw that eight workers from government-controlled areas had completed laying the foundations of a temporary pedestrian bypass bridge connected to the southern edge of the broken section of the Stanytsia Luhanska bridge (15km north-east of Luhansk) and had completed mounting scaffolding, along with the placement of steel platform plates and wooden boards onto it. On 30 September, the Mission saw 17 workers from government-controlled areas cutting trees 30m east of the northern edge of the broken section of the bridge and also saw 18 workers from government-controlled areas arriving with a truck, an excavator and a roller and subsequently levelling and gravelling the ground 1m north of the broken section of the bridge.

On the afternoon of 30 September, positioned about 100m north of the broken section of the bridge, the SMM heard two shots of small-arms fire (within the time span of six minutes) at

an assessed distance of 1km south-south-east, assessed as inside the disengagement area. Positioned about 110m north of the broken section of the bridge, the SMM heard four shots of small-arms fire at an assessed range of 2km north-west, assessed as outside the disengagement area.

Other disengagement areas⁵

On 29 September, an SMM mini-unmanned aerial vehicle (UAV) <u>again</u> spotted about 34 anti-tank mines (TM-62) inside the disengagement area near Zolote (government-controlled, 60km west of Luhansk), from about 90m south of the northern edge of the disengagement area, about 50m east of road T-1316, to about 70m south of the northern edge, 200m east of road T-1316, assessed as belonging to the Ukrainian Armed Forces. The UAV spotted four Ukrainian Armed Forces soldiers, including three visibly armed, in the southern edge of Katerynivka (government-controlled, 64km west of Luhansk) inside the disengagement area.

A mini-UAV <u>again</u> spotted 12 anti-tank mines (TM-62), inside the Zolote disengagement area, starting about 50m west of road T-1316, about 480m north of the southern edge of the disengagement area, and continuing west for about 120m, assessed as belonging to the armed formations.

On the evening and night of 29 and 30 September, the SMM camera in Zolote recorded five undetermined explosions at an assessed range of 1.5-4km south-south-east, assessed as inside the disengagement area; two projectiles in flight at an assessed range of 1-3km east and an undetermined explosion at an assessed range of 3-5km east-north-east, all assessed as outside the disengagement area but within its 5km periphery, as well as an undetermined explosion at an assessed range of 2.5-4km south-south-east (unable to be assessed whether inside or outside the disengagement area). On 30 September, positioned on the southern edge of the disengagement area near Zolote, the SMM heard an undetermined explosion at an assessed range of 1-2km west-north-west, assessed as inside the disengagement area.

On 30 September, about 850m south of the northern edge of the Zolote disengagement area, and about 90m north of the railway tracks, the Mission again saw a barbed wire with an attached manufactured "Stop" (in Latin letters) sign on it, along with a tube of the unused rocket-propelled grenade (RPG-22) placed on the ground on the western edge of the road T-1316; both obstacles were removed by the Ukrainian Armed Forces to allow the SMM passage through the disengagement area. The Mission saw for the first time an 82mm mortar tailfin inside the disengagement area, in the middle of the T-1316 road, about 136m southeast of the tube of the unused RPG-22, assessed as exploded.

On 29 September, inside the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk), an SMM mini-UAV <u>again</u> spotted an armoured combat vehicle (ACV) (type undetermined) about 1.2km south of the area's northern edge and 1.3km east of its western edge, assessed as belonging to the Ukrainian Armed Forces. An SMM mini-UAV spotted up to seven Ukrainian Armed Forces soldiers, inside the disengagement area.

On 28 and 29 September, an SMM mini-UAV <u>again</u> spotted a probable machine gun about 5m south of the northern edge of the disengagement area near Petrivske and about 390m west of its eastern edge, and a probable machine gun about 10m north of its southern edge and about 60m west of its eastern edge next to three men in camouflage uniforms assessed as belonging to the armed formations, all inside the disengagement area and near positions of the armed formations.

Outside the disengagement area near Petrivske, on the road between Viktorivka (non-government-controlled, 42km south-west of Donetsk) and Bohdanivka (government-controlled, 41km south-west of Donetsk), the same UAV <u>again</u> spotted 28 anti-tank mines (TM-62) laid across the road about 160m north of the disengagement area and about 150 anti-tank mines (TM-62) in a field running from 60m north of the northern edge of the disengagement area to about 680m further north.

On 30 September, positioned close to the disengagement area near Petrivske, the SMM observed a calm situation; however, it was <u>again</u> restricted accessing its camera site near the disengagement area.*

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed eight weapons in violation of withdrawal lines, all in government-controlled areas of Luhansk region. The SMM also observed at least seven weapons beyond their withdrawal lines but outside storage sites in government-controlled areas of both Donetsk and Luhansk regions (for more details, see the tables below).

Weapons that the SMM could not verify as withdrawn⁷

At heavy weapons holding areas in government-controlled areas of Luhansk region 28 September

The SMM noted that:

- three self-propelled howitzers (2S3 *Akatsiya*, 152mm), and seven tanks (T-80) were present; and
- two self-propelled howitzers (2S3) were missing for the first time, whereas 58 tanks (six T-72, 52 T-64), 11 self-propelled mortars (2S9 *Nona*,120mm) and 22 self-propelled howitzers (2S1 *Gvozdika*, 122mm) continued to be missing.

Indications of military and military-type presence in the security zone⁸

Government-controlled areas 28 September

An SMM long-range UAV spotted:

- 17 ACVs, including at least ten infantry fighting vehicles (IFV) (BMP-1), near Dyliivka (49km north of Donetsk);
- an armoured reconnaissance vehicle (BRDM-2) near Svitlodarsk (57km north-east of Donetsk);
- two armoured personnel carriers (APC) (BTR-80) and an ACV near Malynove (19km north-east of Luhansk);
- an ACV near Shyrokyi (38km north-east of Luhansk);
- a probable APC (MT-LB) near Pidlisne (70km north-west of Luhansk); and
- an APC (MT-LB) and an IFV (BMP-2) near Oleksandropillia (71km west of Luhansk).

An SMM mini-UAV spotted an IFV (BMP variant) near Krasnohorivka (21km west of Donetsk).

29 September

An SMM mini-UAV spotted three IFVs (BMP-1) in Zolote-4/Rodina (59km west of Luhansk).

30 September

The SMM saw:

- an APC (BTR-70) near Novobakhmutivka (28km north of Donetsk);
- an IFV dug in a camouflaged revetment and two APCs (BTR-70) near Popasna;
- an APC (MT-LB) near Troitske (69km west of Luhansk); and
- an IFV dug in a camouflaged revetment near Novozvanivka (70km west of Luhansk).

Non-government-controlled areas

28 September

An SMM mini-UAV spotted an ACV inside the disengagement area near Petrivske.

Unexploded ordnance (UXO) and remnants of exploded devices between Popasna and Molodizhne

On 30 September, the SMM <u>again</u> saw remnants of an exploded grenade (PG-7) on the northern edge of road T-0504, about 1.5km south-west of Molodizhne (non-government-controlled, 63km west of Luhansk). On the eastern edge of the same road, the Mission <u>again</u> saw remnants of an exploded anti-tank grenade (PG-7) and a tailfin of an exploded recoilless gun (SPG-9) and an unexploded anti-tank grenade (PG-7) fuse with a damaged warhead. On the western edge of the same road, it <u>again</u> saw a part of an 82mm mortar round still with explosive content inside but without a fuse or a tailfin.

SMM facilitation of operation of and repair works to civilian infrastructure

The SMM monitored adherence to the ceasefire to facilitate repairs to water pipelines between Zolote-3/Stakhanovets (government-controlled, 61km west of Luhansk) and Popasna, to power lines near Holmivskyi (non-government-controlled, 49km north-east of Donetsk), as well as to enable the drilling of wells near Raivka (non-government-controlled, 16km north-west of Luhansk). The Mission also monitored adherence to the ceasefire to facilitate demining and dismantling of a bridge near Shchastia (government-controlled, 20km north of Luhansk).

The SMM continued to facilitate the operation of the DFS (15km north of Donetsk) and monitor the security situation around the pumping station near Vasylivka (non-government-controlled, 20km north of Donetsk).

Border areas outside government control

On 30 September, while at a border crossing point near Uspenka (73km south-east of Donetsk) for about one hour, the SMM saw 19 cars (four with Ukrainian and three with Russian Federation licence plates and 12 with "DPR" plates), 13 covered cargo trucks (eight with Ukrainian, one with Russian Federation and one with Belarusian licence plates, as well as three with "DPR" plates), and two buses (one with Ukrainian licence plates and one with "DPR" plates) entering Ukraine. It also saw 44 cars (nine with Ukrainian, four with Russian Federation licence plates, 30 with "DPR" and one with "LPR" plates), 16 covered cargo trucks (nine with Ukrainian, four with Russian Federation, one with Belarusian licence plates, as well as two with "DPR" plates), and three buses (one with Russian Federation licence plates, and two with "DPR" plates) exiting Ukraine.

While at a border crossing point near Marynivka (78km east of Donetsk), for about one hour, the SMM saw three cars (one with Russian Federation licence plates and two with "DPR" plates), one minibus with Armenian licence plates and a bus with "DPR" plates as well as two men and a woman entering Ukraine. It also saw 17 cars (three with Ukrainian and eight with Russian Federation licence plates, and six with "DPR" plates), three trucks (one with Ukrainian licence plates with no cargo and two with "DPR" plates and closed cargo), two buses with "DPR" plates and a man exiting Ukraine.

While at a pedestrian border crossing point near Ulianivske (61km south-east of Donetsk) for about 30 minutes, the SMM saw no pedestrians entering or exiting Ukraine.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, UXO and other impediments — which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the Government (for example, see SMM Daily Report 30 September). The SMM's operations in Donetsk and Luhansk regions remain restricted following the fatal incident of 23 April 2017 near Pryshyb; these restrictions continued to limit the Mission's observations.

Denial of access:

- At a checkpoint on the northern edge of Petrivske (non-government-controlled, 41km south of Donetsk), an armed member of the armed formations <u>again</u> denied the SMM

- passage, citing "engineer's work and demining in the area", thereby restricting the SMM's access to its camera in Petrivske.
- At a checkpoint west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), an armed members of the armed formations, <u>again</u> denied the SMM passage citing "ongoing demining activities".
- At a checkpoint near Shevchenko (non-government-controlled, 69km south of Donetsk), three members of the armed formations denied the SMM passage citing lack of awareness of the SMM visit to the village by those in control.

Delay:

- At a checkpoint west of Verkhnoshyrokivske, a member of the armed formations again allowed the SMM to proceed only after about 80 minutes of waiting.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.

Other impediments:

- On the evening of 28-29 September, an SMM long-range UAV lost its dual GPS signal, due to signal interference assessed as caused by jamming, while flying near Ivanopillia (government-controlled, 51km north of Donetsk) and Khoroshe (non-government-controlled, 36km west of Luhansk). The same UAV also lost its GPS signal due to signal interference assessed due to probable jamming, while flying over government-and non-government-controlled areas of Luhansk region and government-controlled areas north of Donetsk region.⁹
- On 30 September, on two occasions, an SMM mini-UAV lost its GPS signal due to signal interference assessed as caused by probable jamming while flying in the vicinity of Hnutove (government-controlled, 90km south of Donetsk).

When information is not known (indicated with an "N/K"), the SMM was unable to ascertain such information due to distance, weather conditions and/or other considerations. Ceasefire violations recorded by more than one patrol and assessed to be the same are entered only once.


