


Daily Report 276/2019

21 November 2019¹

Summary

- Compared with the previous reporting period, the SMM recorded fewer ceasefire violations in Donetsk region and no ceasefire violations in Luhansk region.
- The construction work at Stanytsia Luhanska Bridge was finalized; civilians started walking over the new section of the bridge while travelling towards government-controlled areas and in the opposite direction.
- The SMM received a Note Verbale from the Ministry of Foreign Affairs of Ukraine and a notification from the armed formations about the completion of demining activities inside the Petrivske disengagement area.
- The SMM continued to monitor the security situation inside and near the Zolote disengagement area.
- The SMM monitored adherence to the ceasefire to facilitate repair works to power lines near non-government-controlled Spartak, in Donetsk region.
- Restrictions of the SMM's freedom of movement continued, including at checkpoints of the armed formations near Shevchenko and Verkhnoshyrokivske.*

Ceasefire violations²





In Donetsk region, the SMM recorded fewer ceasefire violations, including, however, a similar number of explosions (about 300), compared with the <u>previous reporting period</u>. The majority of ceasefire violations, including the majority of explosions, were recorded in areas south-east of Svitlodarsk (government-controlled, 57km north-east of Donetsk), south-east and south-south-east of Pyshchevyk (government-controlled, 84km south of Donetsk), as well as at south-westerly directions of Bohdanivka (government-controlled, 41km south-west of Donetsk), close to the disengagement area near Petrivske (non-government-controlled, 41km south of Donetsk).

In Luhansk region, the SMM recorded no ceasefire violations. During the <u>previous reporting</u> period, the SMM recorded one explosion.

Construction work at Stanytsia Luhanska Bridge finishes and new section opens for civilian crossings

On 20 November, inside the disengagement area near Stanytsia Luhanska (government-controlled, 16km north-east of Luhansk), the SMM saw the President of Ukraine and 40 representatives of media outlets arriving at Stanytsia Luhanska and walking to the northern edge of the newly constructed section of the bridge. Afterwards, at 15:42, workers from government-controlled areas removed the fences and people starting walking over the aforementioned section. Part of the bridge was destroyed during the conflict in 2015. Since then, people have had to walk over temporary steep wooden ramps in all weather conditions. This crossing has been particularly difficult for the elderly and for people with disabilities.

In the morning of 20 November, between the southern edge of the newly constructed section of the bridge and the checkpoint of the armed formations, the SMM observed at least seven members of the armed formations (wearing armbands with "JCCC" written on them). The SMM saw also senior members of the armed formations together with about 15 representatives of media outlets standing at the southern edge of the aforementioned section of the bridge.

Disengagement areas near Petrivske and Zolote⁵

On 20 November, positioned about 2km north of **Petrivske**, the SMM heard three bursts of heavy-machine-gun fire 2-3km south-south-west (assessed as inside the Petrivske disengagement area).

On the same day, positioned in Bohdanivka, the SMM saw about 20 members of the State Emergency Service of Ukraine near the Petrivske disengagement area. A Ukrainian Armed Forces officer of the Joint Centre for Control and Co-ordination (JCCC) told the SMM that demining activities inside the area had been completed. Later that day, the SMM received a Note Verbale from the Ministry of Foreign Affairs of Ukraine informing the SMM about the completion of demining activities in certain areas inside the Petrivske disengagement area, as well as the removal of barriers, the clearance of the area from mines and other explosive ordnance and the fencing-off of additional areas assessed as to be contaminated with explosive ordnance. The SMM also received a letter from the armed formations informing the SMM about the completion of basic demining activities, a thorough inspection of the area and

adjacent territories, as well as the fencing-off of areas assessed to be contaminated with unexploded ordnance (UXO).

Positioned in Bohdanivka, the SMM heard ten undetermined explosions and about 115 shots and bursts of heavy-machine-gun and (30mm) cannon fire, most of which were assessed as at a range of 2-3km south-south-east, south-east and south-south-west, and all as outside the disengagement area.

On 19 November, the SMM saw two Ukrainian Armed Forces personnel cutting wood inside a military position on the northern edge of the **disengagement area near Zolote** (government-controlled, 60km west of Luhansk) (see SMM Daily Report 28 October 2019). On the same day, the SMM saw a military truck exiting the disengagement area from the direction of Katerynivka (government-controlled, 64km west of Luhansk), as well as Ukrainian Armed Forces personnel continuing building defensive positions outside the disengagement area, south of Zolote-4/Rodina (government-controlled, 69km west of Luhansk) (see SMM Daily Report 20 November 2019).

On 20 November, positioned on the southern edge of the disengagement area, the SMM saw seven members of the armed formations and 17 workers from non-government-controlled areas entering the area. Positioned at the same location, the SMM heard three explosions 1-2km north, assessed as being controlled detonations; it also saw a non-SMM unmanned aerial vehicle flying at an altitude of 50-60m in a southerly direction and turning over the checkpoint of the armed formations before heading north.

Withdrawal of weapons

The SMM continued to monitor the withdrawal of weapons in implementation of the Memorandum and the Package of Measures and its Addendum.

The Mission observed a weapon in violation of the withdrawal lines in a government-controlled area of Donetsk region. It observed 47 weapons beyond withdrawal lines but outside of designated storage sites in government-controlled areas of Donetsk region (for further details, see the tables below).

Weapons storage sites

19 November

At permanent storage sites in government-controlled areas of Donetsk region The SMM noted that 151 tanks (139 T-64 and 12 T-80), seven towed guns (D-44, 85mm) and 20 mortars (ten 2B9 *Vasilek*, 82mm; four M120-15 *Molot*, 120mm; and six PM-38, 120mm) continued to be missing.

20 November

At a permanent storage site in a non-government-controlled area of Donetsk region The SMM noted that 11 tanks (T-64) continued to be missing.

At a permanent storage site in a non-government-controlled area of Luhansk region The SMM noted that all weapons were present.

Indications of military and military-type presence in the security zone⁶

The SMM observed military presence inside the security zone in government-controlled areas of Luhansk and Donetsk regions, as well as in non-government-controlled areas of Donetsk region, including infantry fighting vehicles and armoured personnel carriers (for further details, see the table below).

SMM facilitation of repairs to and operation of critical civilian infrastructure

The SMM monitored adherence to the ceasefire to facilitate repair works to power lines near Spartak (non-government-controlled, 9km north of Donetsk). The SMM also continued to facilitate the operation of the Donetsk Filtration Station (15km north of Donetsk) and monitored the security situation in areas near the Pumping Station close to Vasylivka (non-government-controlled, 20km north of Donetsk).

Border areas outside government control

While at a border crossing point near Marynivka (78km east of Donetsk) for about one hour, the SMM saw 15 cars (four with Ukrainian, nine with Russian Federation and one with Georgian licence plates, as well as one with "DPR" plates) and one bus with "DPR" plates and approximately ten passengers on board entering Ukraine. The SMM also saw eight cars (two with Ukrainian and three with Russian Federation licence plates, as well as three with "DPR" plates), two covered cargo trucks (one with Russian Federation licence plates and one with "DPR" plates) and one bus with "DPR" plates and approximately 75 passengers on board exiting Ukraine.

While at a border crossing point near Uspenka (73km south-east of Donetsk) for about one hour, the SMM saw 40 cars (six with Ukrainian, five with Russian Federation and one with Georgian licence plates, as well as 28 with "DPR" plates), a covered cargo truck with Ukrainian licence plates and two buses (one with Russian Federation licence plates and one with "DPR" plates) entering Ukraine. The SMM also saw 22 cars (six with Ukrainian and five with Russian Federation licence plates, as well as 11 with "DPR" plates) and two covered cargo trucks with Ukrainian licence plates exiting Ukraine.

The Mission continued monitoring in Kherson, Odessa, Lviv, Ivano-Frankivsk, Kharkiv, Dnipro, Chernivtsi and Kyiv.

*Restrictions of the SMM's freedom of movement or other impediments to fulfilment of its mandate

The SMM's monitoring and freedom of movement are restricted by security hazards and threats, including risks posed by mines, unexploded ordnance (UXO) and other impediments – which vary from day to day. The SMM's mandate provides for safe and secure access throughout Ukraine. All signatories of the Package of Measures have agreed on the need for this safe and secure access, that restriction of the SMM's freedom of movement constitutes a violation, and on the need for rapid response to these violations. They have also agreed that the JCCC should contribute to such response and co-ordinate mine clearance. Nonetheless, the armed formations in parts of Donetsk and Luhansk regions frequently deny the SMM access to areas adjacent to Ukraine's border outside control of the

Government (for example, see <u>SMM Daily Report of 19 November 2019</u>). The SMM's operations in Donetsk and Luhansk regions remain restricted following <u>the fatal incident of 23 April 2017 near Pryshyb</u>; these restrictions continued to limit the Mission's observations.

Denial of access:

- At the eastern entrance of Shevchenko (non-government-controlled, 69km south of Donetsk), two armed members of the armed formations <u>again</u> prevented the SMM from proceeding west, citing "sniper fire in the area". While at the checkpoint, the SMM saw a tractor and two cars driving through towards the village.
- At a checkpoint about 600m west of Verkhnoshyrokivske (formerly Oktiabr, non-government-controlled, 85km south of Donetsk), one armed member of the armed formations denied the SMM passage, citing "ongoing demining activities in areas near Sakhanka (non-government-controlled, 97km south of Donetsk) and Pikuzy (formerly Kominternove, non-government-controlled, 92km south of Donetsk)". While at the checkpoint, the SMM saw civilian cars driving through in both directions.

Regular restrictions related to disengagement areas and mines/UXO:

- The sides continued to deny the SMM full access, as well as the ability to travel certain roads previously identified as important for effective monitoring by the Mission and for civilians' movement, through failure to conduct comprehensive clearance of mines, UXO and other obstacles.
