## **Background Information**

The topic of renewable sources of energy has gained greater importance in Azerbaijan in recent years. This is reflected, for instance, by Azerbaijan's accession to the newly-established *International Renewable Energy Agency* (IRENA) on 10 June 2009, the decree by H.E. President Ilham Aliyev on the creation of a *National Renewable Energy Agency* on 16 July 2009 as well as the adoption of the *State Programme on the Use of Alternative and Renewable Energy Sources in the Azerbaijan Republic*; approved by Presidential Decree on 21 October 2004. However, there are only a few examples to date of the practical application of renewable sources of energy other than hydro power.

In order to contribute to the further development of the renewable energy sector in Azerbaijan, the OSCE Office in Baku - in co-operation with the Ministry of Industry and Energy and the EU Twinning Project on Legal Approximation and Structural Reform in the Energy Sector of Azerbaijan - organizes a conference on international best-practice in creating a legal and regulatory framework conducive to the development of renewable energy. The event also intends to give a comprehensive overview on the current state of the renewable energy sector in Azerbaijan, including the legal, political and economic conditions, and provides an opportunity to discuss possible future developments.

The conference addresses relevant Azerbaijani government agencies, civil society organizations, private sector representatives as well as International Organizations. The event is part of the OSCE Office in Baku's efforts to strengthen a multi-stakeholder dialogue on energy policy in Azerbaijan and promote the wider application of renewable sources of energy.
