### **STATEMENT BY**

THE DELEGATION OF THE CZECH REPUBLIC (ALSO ON BEHALF OF GERMANY, THE UNITED STATES OF AMERICA, CANADA, DENMARK, FINLAND, THE UNITED KINGDOM, ICELAND, NORWAY, THE NETHERLANDS, POLAND, ROMANIA, SLOVAKIA AND SWEDEN)

Mr. Chairperson,

The Czech Republic is delivering this statement also on behalf of the following countries: Germany, the United States of America, Canada, Denmark, Finland, the United Kingdom, Iceland, Norway, the Netherlands, Poland, Romania, Slovakia and Sweden.

The 14 participating States that invoked the Moscow Mechanism have learned with concern that Belarus did not issue a visa to the official OSCE Moscow Mechanism rapporteur Professor Emmanuel Decaux and is not co-operating with him. Such behaviour constitutes a clear breach of Belarusian commitments under the Moscow Mechanism and is in contradiction with Belarusian promises to further co-operate with the OSCE.

It is our view that a particularly serious threat to the fulfilment of the provisions of the OSCE human dimension has arisen in Belarus. We therefore called for a fact-finding mission to examine concerns regarding the demonstrations that took place in Belarus on 19 December 2010, as well as developments since then, in order to produce an independent and impartial report containing facts, proposals and advice. The recent sentencing of presidential candidate Andrey Sannikov and several other participants in the December demonstrations only confirms the urgent need for independent scrutiny of Belarusian compliance with OSCE human rights commitments.

We consider the Moscow Mechanism, which was established by consensus and in good faith by all participating States, a useful OSCE tool of co-operation and dialogue, as well as a means for clarification of possible misunderstandings. The rapporteur's report is intended to assist Belarus to meet its commitments on human rights and fundamental freedoms.

We recall that our Heads of State or Government reconfirmed at the recent Astana summit all OSCE *aquis*, including the Moscow Mechanism. We therefore urge Belarus to reconsider its position, to permit Professor Decaux to visit Belarus, and to provide him with all information and assistance required to fulfil his mission.

#### STATEMENT BY THE DELEGATION OF BELARUS

Mr. Chairperson,

We have listened carefully to the statements by the delegation of the Czech Republic on behalf of 14 countries and by the delegation of Hungary on behalf of the European Union.

In this connection, we should like to recall our position of principle as regards the group of participating States that has initiated the so-called Moscow Mechanism with respect to Belarus

The Belarusian Government has from the outset referred to the absence of objective grounds for invoking the aforementioned mechanism. The initiative of the 14 countries has ignored the open dialogue which we have conducted and are continuing to conduct within the framework of the OSCE Permanent Council and the Office for Democratic Institutions and Human Rights (ODIHR). It has also effectively contravened the provisions of the Moscow Document itself, since it has proposed sending a rapporteur mission to Belarus at the same time as ODIHR experts are already present in the country with a similar mandate.

The Republic of Belarus does not regard the person mentioned in the Czech Republic's statement, Mr. Decaux, as an OSCE Moscow Mechanism rapporteur and does not consider itself in this case to be bound by the relevant co-operative provisions of the Moscow Document. Our delegation has duly informed the participating States concerned and the Director of the OSCE ODIHR of this fact.

I believe that in this situation the reasons for not issuing a visa to Mr. Decaux are fairly obvious. In any case, the issuance of a visa or a permit to enter the territory of a country is a participating State's sovereign right.

It is worth pointing out, however, that the so-called rapporteur approached the Belarusian authorities for a visa after the two weeks that he had been given to prepare a report in accordance with paragraph 11 of the Moscow Document had elapsed, and then, for some reason, he requested a visa for June. This, in our view, is further graphic evidence of the fact that the initiative of the 14 countries is not in keeping with the essence, procedure or form of the OSCE Moscow Mechanism. It has been ordered for political reasons.

Belarus is open to other, genuinely relevant and mutually beneficial forms of co-operation within the OSCE and with participating States, and will continue constructive dialogue on this matter with the Chairmanship.

# DECISION No. 999 RECOMMENDATION TO REAPPOINT AMBASSADOR JANEZ LENARČIČ AS DIRECTOR OF THE OFFICE FOR DEMOCRATIC INSTITUTIONS AND HUMAN RIGHTS

The Permanent Council,

Recalling the 1990 Charter of Paris and the decision of the Ministerial Council taken at its second meeting in Prague in 1992 concerning the development of the Office for Democratic Institutions and Human Rights (ODIHR),

Noting that the term of office of the current Director of the ODIHR, Ambassador Janez Lenarčič, will expire on 30 June 2011,

- 1. Requests the Chairperson of the Permanent Council to transmit to the Chairperson-in-Office the draft decision of the Ministerial Council on the reappointment of Ambassador Janez Lenarčič as Director of the ODIHR as contained in document MC.DD/1/11/Rev.1 of 17 May 2011;
- 2. Recommends that the Ministerial Council adopt that decision through a silence procedure with the period of silence expiring on 30 May 2011, at noon CET.

# INTERPRETATIVE STATEMENT UNDER PARAGRAPH IV.1(A)6 OF THE RULES OF PROCEDURE OF THE ORGANIZATION FOR SECURITY AND CO-OPERATION IN EUROPE

"Mr. Chairperson,

I am honoured today to take the floor on behalf of Iceland, Liechtenstein, Norway, Switzerland and Canada on this very important issue and bring to your attention this interpretative statement.

Mr. Chairperson,

By exceptionally accepting in this case to make a reference to the 1990 Charter of Paris and the wording 'reappointment' instead of 'extension' as would have been the more appropriate word, we firmly underline that this does not mean consenting to any interpretation that would put in doubt the validity either of previous or future extensions of the terms of the heads of institutions.
