STATEMENT BY THE DELEGATION OF LITHUANIA

Mr. Chairperson,

As the distinguished Ambassador of the United States of America referred to Lithuania in his statement, please allow me also to say a few words in my national capacity.

I should begin, though, by emphasizing that Lithuania fully aligns itself with the statement on this current issue delivered by the delegation of Germany on behalf of the European Union.

First of all, I wish to express my sincere thanks to the Honourable Ambassador James S. Gilmore for remembering the declaration made on 23 July 1940 by the acting Secretary of State of the United States of America, Mr. Sumner Welles, on the non-recognition of the occupation of the Baltic States.

Indeed, today it is exactly 80 years since that declaration was issued. The people of Lithuania will forever remain grateful to the US Administration and to the people of the United States for their principled stance, solidarity and support from the very first days of the occupation of Lithuania by the Soviet Union in June 1940 – an occupation that had been secretly agreed on by the totalitarian Soviet and Nazi regimes with the signature of the Molotov-Ribbentrop Pact and its secret supplementary protocols in August 1939, and which was carried out soon afterwards.

For Lithuania, the Welles Declaration was, and still is, not merely a political declaration. It was the basis for a comprehensive policy by the United States of non-recognition of our country's occupation. Accordingly, Lithuania's financial assets and gold reserves deposited with the US Federal Reserve were not handed over to the Soviets, Lithuania's embassy in Washington remained the only Lithuanian State institution that was fully operational throughout the entire period of occupation, and the Lithuanian national flag continued to be flown at the Department of State during all those years.

The Welles Declaration also served as inspiration for the Lithuanian men and women engaged in the country-wide resistance movement and in underground dissident activities.

Secondly, it is not least because of our country's historical experience that Lithuania is such a staunch supporter of the sovereignty and territorial integrity of Ukraine, Georgia and all other OSCE participating States.

In this context, allow me to reiterate Lithuania's full support for the European Union's policy of non-recognition of the illegal annexation of the Crimean peninsula, and for similar non-recognition policies by other Western nations, including the United States. Here I wish also to recall another declaration mentioned by Ambassador Gilmore, namely the declaration on Crimea issued on 24 July 2018 by the US Secretary of State, Mr. Michael R. Pompeo.

The people of Lithuania know very well how important such non-recognition policies are. We also know that, sooner or later, they produce results.

We are confident that not only the people of the occupied Crimean peninsula of Ukraine but also the people of the occupied territories of Georgia will one day regain their freedom and be reunited with their compatriots. We will continue to uphold the relevant non-recognition policies until that day arrives, and we will always remain committed to supporting the independence, sovereignty and territorial integrity of these countries.

STATEMENT BY THE DELEGATION OF UKRAINE

Mr. Chairperson,

We wish to inform the Permanent Council that – in accordance with the Constitution of Ukraine and the Electoral Code of Ukraine, and pursuant to the relevant decree of the Verkhovna Rada of Ukraine (the Ukrainian Parliament) – regular elections for the deputies of local councils and for village, town and city mayors are scheduled to be held in Ukraine on 25 October 2020.

In line with the 1990 Copenhagen Document and the 1999 Istanbul Document, allow me to extend, on behalf of the Ukrainian Government, an invitation to the OSCE Office for Democratic Institutions and Human Rights (ODIHR) to observe the aforementioned elections. Although the provisions of the Copenhagen and Istanbul Documents refer to elections held at the national level, Ukraine is inviting the ODIHR to monitor these local elections because of its high regard for the Office's election monitoring activities, and also because Ukraine has traditionally maintained constructive co-operation with the ODIHR in the electoral sphere. We encourage other participating States to act in the same vein.

The Ukrainian Government is committed to sparing no effort to ensure free, fair and transparent elections in accordance with internationally recognized standards for the conduct of democratic elections as well as with national legislation.

I wish to draw your attention to Part IX, Article 58, paragraph 3, of the Electoral Code of Ukraine, which lays down the eligibility criteria for monitors. In particular, no citizen (national) of a State recognized by the Verkhovna Rada as an aggressor State or an occupying State, nor any individual whose nomination has been initiated or submitted by such a State, may act as an official observer.

We look forward to welcoming the OSCE ODIHR election observation mission at the forthcoming local elections in Ukraine and stand ready to provide, in accordance with our national legislation, all necessary assistance to the work of the international observers.

I thank you, Mr. Chairperson, and kindly ask you to attach this statement to the journal of today's meeting.
