STATEMENT BY THE DELEGATION OF THE FORMER YUGOSLAV REPUBLIC OF MACEDONIA

It is with great honour and pride that I can inform the PC that, today in Skopje, the "Holocaust Memorial Centre of Macedonia" was opened. The Centre covers 2,700 square metres and has been built using funds from the property of the killed Macedonian Jews with no living heirs, through implementation of the Law on Denationalization, which laid the groundwork for the establishment of the Holocaust Fund for the Macedonian Jews.

In this way, the Republic of Macedonia became one of the very few countries to have resolved the issue of the property of the deported Jews.

This is the fourth Memorial Centre dedicated to the victims of the Holocaust, after Yad Vashem in Jerusalem, the Memorial Museum Centre in Washington, DC, and the Jewish Museum in Berlin.

In 1942, the Nazi forces rounded up 98 per cent of Macedonia's Jewish population (7,148 Macedonian Jews) and sent them to Treblinka Extermination Camp in Poland. The Macedonian Jewish community was restored in December 1944 from just under 50 survivors. Today, the community has slightly more than 200 members.

As President Gjorge Ivanov stated two days ago: "For many, the Jewish Holocaust represents both the most cruel and the most real metaphor of the twentieth century – a metaphor on human madness, leading to mass killings – a crime that before Raphael Lemkin coined it in 1943 didn't even have a name! That was most probably because nobody believed that it was possible. But, unfortunately, we have so often witnessed genocide as an evil shadow that follows mankind. That is why mankind should not forget what happened, in order to make sure it never happens again."
